**ORDER**

The complainant alleged a superior court judge violated his civil rights, took advantage of him, engaged in ex parte communications, had a conflict of interest, covered up criminal conduct, and made improper rulings in a family law matter.

The responsibility of the Commission on Judicial Conduct is to impartially determine if a judicial officer engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the commission is limited to this mission.

The commission does not have jurisdiction to review the legal sufficiency of a judicial officer's rulings. In addition, the commission found no evidence of ethical misconduct and concluded that the judicial officer did not violate the Code in this case. Accordingly, the complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23(a).

Commission member Christopher P. Staring did not participate in the consideration of this matter.

Dear Arizona Commission on Judicial Misconduct,

I have been hospitalized the [redacted] My civil rights have been violated, and I have been taken advantage of. I am [redacted] and [redacted] I have a right to a trial. I have a right to receive notice of a trial. I have a right to retain representation. All of these are constitutional rights afforded me under the constitution. I received no notice of a trial. I had no trial. I had no representation. [redacted] of [redacted] Court violated all of these constitutional rights of mine, which I had with respect to a trial, due process, and the implementation of the law.

[redacted] awarded [redacted] of my retirement, [redacted] of my home, [redacted] of my property, [redacted] of my children [redacted], and [redacted]; and [redacted] of everything else to my wife and opposing council through attorney fees and court awards. [redacted] of my sole and separate property, [redacted] of my wife's sole and separate property, [redacted] of my community property, and [redacted] of my wife's community property were given to my wife and her council through attorney fees and court awards by [redacted] out of no other reason by him than cruelty, hatred, and pure evil towards me and his fellow man. All of my rights were violated, and all of this was done through fraud and abuse.

[redacted] refused to allow me to see my children while my wife worked, and ordered me to pay strangers for childcare, instead of allowing my children's own father to care for them.

[redacted] believed opposing council that I had [redacted] and harmed my children during a court ordered vacation he granted, and refused to allow me to see my children.

[redacted] conducted a child custody evaluation over [redacted] during which time I only saw my children [redacted] days, he then ordered that I can't see my children. [redacted] is incompetent, a fraud, and corrupt.

[redacted] works for [redacted] and [redacted] - who are the opposing council. [redacted] awarded the financial and personal gain of [redacted] of all community and sole and separate property to the opposing party of which he works for. This is corruption. It is collusion, conspiracy, fraud, and injustice. My spouse and her council have gained over [redacted] in the past [redacted] while I am over [redacted] in debt.

allowed the opposing council whom he works for to work as [redacted] lawyers in family law through granting [redacted] and making me pay all of their attorney fees. My wife never paid her attorney fees, and I was forced to pay all of her attorney costs on a contingency basis by [redacted] orders. My wife is [redacted] and had all of our money: why did [redacted] do all of this? [redacted] is evil, and must be removed as a judge, and punished for his crimes.

I have done nothing wrong, illegal, or otherwise. I am a good husband, father, and person. I served in numerous positions in my life which show what good standing I have with court. I served on the [redacted] I received the [redacted] from the [redacted] in [redacted] I worked at increasing levels of responsibility for [redacted] for [redacted] years. Most notably, I spent the past [redacted] years designing and producing [redacted] protecting our country from enemies. I am a [redacted] in the [redacted] I served as [redacted] of the [redacted] the [redacted] of the [redacted]

I trained [redacted] how to use [redacted] and [redacted] for [redacted] years in [redacted] I coached my children's baseball and soccer teams. I am active with youth in my university, music, religion, education, sports, and science. I have participated in all of my children's activities of football, cheerleading, scouts, astronautics, music, mass, swimming, gymnastics, soccer, and baseball. I have worked very hard for my country for over [redacted] years, and I am a patriot. No one should be treated like this, and certainly the Father/Husband that I am should not be treated in this manner.

Please let me know what you can do to help with regard to my home being taken from my family, my retirement being taken from my family's future, my assets being taken putting my family in poverty, and most significantly my children being taken who are the most important purpose in my life. I want my family to have a home to live in, I want to be able to afford medical treatment to regain good health, I want to get my job back that was taken from me, I want my children back that were taken from me. I can provide evidence of my [redacted] and [redacted] and can provide further information to you upon request regarding this matter.
