ORDER

The Complainant alleged a justice of the peace was racially biased against her, refused to review her evidence, and engaged in improper demeanor. The complainant also alleged a pro tem justice of the peace was racially biased against her, refused to review her evidence, and altered the court recording.

The responsibility of the Commission on Judicial Conduct is to impartially determine if a judicial officer engaged in conduct that violated the provisions of Article 6.1 of the Arizona Constitution or the Code of Judicial Conduct and, if so, to take appropriate disciplinary action. The purpose and authority of the Commission is limited to this mission.

The Commission does not have jurisdiction to review the legal sufficiency of a judicial officer's rulings. In addition, the Commission found no evidence of ethical misconduct and concluded that the judicial officers did not violate the Code in this case. Accordingly, the Complaint is dismissed in its entirety, pursuant to Rules 16(a) and 23(a).

Dear Sir,

This is a shorter version on the incident that took place in the [redacted] where Judge [redacted] resides. I already sent a complaint in on Judge [redacted]. I [redacted], am an elderly, disabled, [redacted]. I live in [redacted] with my two daughters. We lived here for about [redacted] yrs. I had been undergoing harassment from a Mr. [redacted] a Mr. [redacted], and a [redacted] wife of [redacted].

I purchased land in the [redacted] and I had a mobile home moved there. I paid about [redacted] of my savings just to move onto the land. Also, during that time, Mr. [redacted] and Mr. [redacted] were illegally using my land. When I moved in, I paid [redacted] to a gentleman to put up a fence all around the land. There are only [redacted] that live in our house. I began getting harassed by Mr. [redacted] and [redacted].

first. Mr. ... and I had become friends, ~~or~~ or so I thought. After wife asked me was I going to use that part of the land, they use to use, I said " ". After I told her I was going to use it for my driveway and parking area, Mr. and Mrs. joined with Mr. ... to harass me: I use to ever pay for the trash and garbage to be picked up, until one day, ^{bought} over some cucumbers to my home, that had maggots crawling out of them, and all over her arms, I just had her to put them down on the ground. I'm deathly afraid of maggots, and I thought it was very rude of her to do that. Yet, I believe in God, I never argued with her, nor said anything to her about it. I tried ignoring the matter. Mrs. and Ms. ... and Mr. and Ms. ... continued harassing me. I called Police several times, esp. on Mr. and Mrs. I didn't want to call Police on the ... because they had illegal immigrants living in their houses, and I felt sorry for them. I even put up tarps, on my fence, so as to avoid them. They tore up my tarps, and picked pieces of wiring off of my fence, until my fence became loose, only on the sides where they lived. Then the

harassment had gotten so bad, that everytime I would walk out my door, my neighbors, both Mr. [redacted] and Mr. [redacted] would start shooting their guns in their yard. They even had men to also start shooting their guns, at a [redacted] across from my house. They also had their friends, and family to harass me. I faced intimidation, exploitation, racism, etc., as my neighbors were trying to frighten me out of my home, and off of my property. Some of the Police tried to help me, but they could only do so much. Then an officer told me to go into the courts, and put in Injunctions against Harassment on them. It took me a while to get the defendants proper names, so a Division at [redacted]

Office kept a file for me, as they also tried to help me, in the Elderly. They started this file, regarding the harassment, since the year of [redacted] long before I was able to get the defendants into Court. They now have all information that happened in the [redacted]. They gave me attorneys to contact. We are all astonished, amazed, and shocked at the outcome in these courts.

I went to the courts to ask for help, from the harassment I am receiving. Instead, Judge [redacted] and Judge [redacted] took the cases, and turned the tables ~~on~~ on me, to make it look as if I were the bad person. The defendants had already been trying to do that. The case was about the defendants harassing me, and trying to frighten me off of my property, so they can gain access to my house and land. Instead they tried to cover that part up, and turned the case into a case about my fence.

I could have went to [redacted] Court for my fence. I told the judges, I was not looking for monetary compensation, but that I just

wanted the harassment to stop, and to be left alone.

On [redacted] I had a court hearing appearance with a Mr. [redacted] as I had gotten an Injunction against Harassment on Mr. [redacted]. I thought it was going to be him to come into the [redacted], to fight about the Injunctions.

Instead it was a young man, whom I had never saw before, I did not know, nor had I ever said anything to him before, and he said his name was Mr. [redacted]. It was he who went and put an Injunction on me!? I had called for that hearing. I thought Mr. [redacted] was going to come into the court.

Judge [redacted] had taken Judge [redacted] place that day, in the [redacted]. I began to explain to the Judge, that I did not know this man, nor had I said anything to him. I asked was his T.D. checked? Judge [redacted] ignored everything I said, and listened to Mr. [redacted]. Mr. [redacted] told the Judge, I had told him, calmly, "I asked, [redacted]?" He said, " [redacted]". It did not make sense to me, because if I did say that to someone, its not harassment. I told the Judge, I never saw any kids playing on my fence, and them trying to tear it down. Mr. [redacted] said,

On a big storm came thru, and knocked my fence onto their side of the yard, and onto his work truck, and when he lifted the fence, to get the truck out, I started saying:

and the next morning when I went outside to clean up the debris, my daughters went with me, and no words, no ill words were ever said. My daughters and I cleaned up the debris, and I had told Mr. and Ms.

that I was sorry for my debris flowing into their yard. We didn't even talk about the fence, as I had just gotten word, my had and I was trying to figure out, how he had

The call had come in as I was walking out my door. We even heard me talking on the phone. Mr. said he lived at the house. I told him, I had never saw him before, again. Mr. says he's always in the back, working, making honey, with their business. Mr. said my fence damaged their truck. I told him, I told the Judge,

Not ill words were spoken, and only Mr. and Ms. were in the yard. There was no talk, about the fence. I paid 2 men to pick the fence up off the ground, and out of their yard. (They loosened my fence. The fence in the front, not near the neighbors, is still nicely intact.) Mr. said on wind came, and knocked the top posts off, and I started yelling at his mom to stop touching my fence. I told the Judge,

No wind was blowing that day, I never knew the wind had knocked off any top posts, nor did I yell at his mom, that day. I said,

Mr. went on to say,

I explained to Mr. that I used to
