**ORDER**

July 10, 2019

The Complainant alleged a superior court judge failed to require DCS to adhere to court orders in a dependency case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Rules 16(a) and 23(a).

I have been making numerous complaint against since the beginning of the case to no resolution. I have not clearly been informed of all the matters in the case and I do not believe that the judges overseeing the case are doing everything in their power to ensure that my rights as a parent are being upheld or that as well as my court ordered attorneys are adhering to court orders , keeping me informed about the case, and adhering to the rights of me and my children or flowingly judicial procedure in attending to the matters of the case. I ask that you follow up with the agencies that I have filed complaints with to obtain all of the information about the continued discrepancies in the case.

Also of concern, There has been information released about me to individual with outside interest including private information I released only to doctors, mail about my children sent to the non-biological father with no interest in the case, and I have not gotten a letter of verification of the dates of cfts, all court

appearances, and confirmation of visits as requested by me from the department and my court ordered attorney. These type of verifications use to be sent out all the time from \_\_\_\_\_ office. But I have been unable to obtain any verification since my appointment to \_\_\_\_\_ as counsel who's appointment as well as \_\_\_\_\_ appointment have not been clarified by the court and is still under question and the ones I have obtained from the department and my attorney contradict each other. I have maintained proof of discrepancies in my email and I am requesting that your office review my file for misconduct.

I affirm, under penalty of perjury, that the foregoing information and the allegations contained in the attached complaint are true. I believe I am being discriminated against and allowed to have my parental rights intruded upon and would like the matter investigated
