**ORDER**

July 10, 2019

The Complainant alleged a superior court judge colluded with others to commit kidnapping and perjury.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Rules 16(a) and 23(a).

*On \_\_\_\_\_ ( \_\_\_\_\_ months ago) is a day that burns in my mind and replays everyday , The day that \_\_\_\_\_ " \_\_\_\_\_ " unlawfully ( without a valid court order and a valid Warrant ) , stripped me from my son (diagnosed \_\_\_\_\_ ) and me a loving mother from my son who needs me in his life to thrive and heal from everything that they have done to him . He was*

taken from the safety of me his loving mother his loving family and friends and now being held a prisoner against his will and mine in a group home without access to what he known at home : His phone , his playstation, his books , his games , his car and train collection and being drugged and having other procedures done without my verbal and written consent which goes against state law : Arizona's Parental State Bill of rights .

My son being treated worse than an animal and no this does not sit well with me at all !

The reason for the unnecessary interference and involvement ? Over one retaliatory phone call from Dr. for me wanting to get referrals from my sons PCP provider for follow up. The unlawful taking of my son was done: 1. without a valid warrant 2. without a valid court order within 3. And without a due process hearing in front of Jury of my peers as stated in our Constitution as my fourth amendment right . No this is not Okay !

An Ex-parte removal is not either a valid warrant nor is it a valid court order . It is a document that is being used to secretly expunge the rights of loving mothers and fathers and the the right to due process . If a crime has been committed do we not have a police force , do we not have already proper courts of record with proper judges and a proper Jury? What then is the purpose the secretive evil institution of unconstitutional family " " ? There is no purpose for the family " " existence and they therefore need to be shut down for good! Arizona's State Bill of Parental Rights declare that I as my sons loving Mother have the right to govern the direction of my son Education and the direction of his Medical Care .

Why was this State law ignored by the and my rights not honored to protect my son , but instead I was retaliated against by for not only protecting my son , but for me wanting the best medical treatment available for my son ?

Where I want my son to be treated , the doctor I want to treat him and what treatment should not be dictated to me by Any Doctor , Hospital nor the
