ORDER

The Complainant alleged a pro tem superior court judge failed to report attorney misconduct, was biased against her, engaged in improper demeanor, and engaged in ex parte communication.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Rules 16(a) and 23(a).

Commission member Roger D. Barton did not participate in the consideration of this matter.

Dear CJC MEMBERS

, in his official capacity as a Judge with pursuant to Article 6, § 31 of the Arizona Constitution violated including Cannons 1, Rule (1.1) A judge shall uphold and promote the independence, integrity: Comply with the Law, Cannon 2 Rules (2.2)(2.15)(2.16) judge shall, perform the duties of judicial office impartially, competently, and diligently: Impartially and Fairness; Respond to Judicial and Lawyer Misconduct; Cooperate with Disciplinary Authorities. Judge hi isdeliberate failure to comply with Rules of Supreme Court set forth Arizona Rules of Judicial Conduct obstructed justice.

Judge deliberately failed to disclose case information to the Arizona Bar disciplinary Authorities relevant to formal complaint lawyer misconduct and engaged in conduct that was bias rather than taking appropriate actions after I wrote, appeared in court, and filed a Motion for Evidence Release. (Motion for Court- Records/Orders/Evidence: . Filed) On I made the judge aware in his official capacity an Attorney hereinafter "appionted counsel" committed violations of the Attorney Professional Rules. Among other misconduct, while on the bench, the judge was prejudicial. After I'd brought to Judge attention I needed to be Pro Se hereinafter "represent self" rather than to represented by appointed counsel for several reasons that included he failed to provide competent representation, failed to use proper and disclosed evidence, to exercise reasonable diligence, deliberately refused to take steps to protect my rights especially upon termination pursuant to 14th amendment hereinafter "due process" and Appeal unjustify orders', and engaged in conduct prejudicial to the adminstration of justice too.

Judge egregiously became embroiled in the matter repeatedly yelling is good and

improperly revoked my right under my fourteenth amendment.

Contrary to _____ in _____ recommended psychosis was deemed unfounded less than 72 hours I was released from _____. The judge cut me short, before I could finish rebutaling, slammed his pen down, turned red and _____. Followed by an angry outburst during the court proceedings, Judge _____ expressed frustration with the judicial system and made a rude and undignified remark, " _____" The judge's conduct appeared to be retaliatory.

Judge _____ conduct constitutes misbehavior so near the presence of the court as to obstruct the " _____" within the meaning of 81 Rules of Supreme Court. Judge _____ improperly inferred denying my motion and failing to perform his duties as outlined in Arizona Rules of Judicial Conduct refusing to respond to a judicial and lawyer misconduct complaint; cooperate with disciplinary authorities hereinafter "Arizona Bar Association."
