**ORDER**

May 21, 2020

The Complainant alleged a superior court judge was biased against him, had threatened him, and had called him stupid.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Colleen E. Concannon did not participate in the consideration of this matter.

His false, malicious, vindictive, accusations against me that were not even true have caused serious Public Ridicule, Public Scandal, and Defamation of Character. Judge has also Illegally raised my bond, and recent No Bond ruling, and I have not committed a crime at all! Judge wreckless, unprofessional, amateur, conduct and behavior towards me recently again caused another Public Article to be published in Dispatch and Facebook. This time Threatening

to hurt/harm me, and cause Serious Physical Injury to me. It was published via Dispatch and social media Facebook. His conduct and professionalism as well as his behavior, his extreme disdain and prejudice against me is unbelievable! NO Judge should treat a Defendant or anyone like he is with me At All. This is completely ILLEGAL, BIAS, UNACCEPTABLE, and misconduct of a Court Judge. I am demanding/requesting to be Released Immediately, pending a thorough investigation on Judge and the Prosecutor's Office! I am Not a criminal at all, I have not committed ANY crimes at all, and I have No priors, No felonies, and I am a pillar of my community! I DO NOT FEEL comfortable at all being Threatened/Harrassed/Intimidated by Judge and my safety is at risk! I don't feel comfortable, safe here at [redacted], as I have already been assaulted multiple times for Alleged Charges I DID NOT IN FACT commit. My wife and kids say I did not do! Multiple times! I wish to exercise MY LEGAL RIGHTS, and I am Demanding to be released from custody so I can get the proper Medical/Mental Health Treatment I deserve as an Honorably Discharged Veteran! I Demand my case be Re-Assigned to another Judge/District/County Immediately, or Veteran's Court/Mental Health Court. I NO longer feel safe and I feel my life is threatened by Judge and inmates who think I'm a child abuser/molester! I would like an emergency Order of Protection filed against Judge for Threatening My Life, Harassment/Intimidation Aggravated for the last months now. Also for Public Slander, Defamation, Abhorrent. Extreme bias, Disdain and prejudice towards me. Discriminating my Mexican American Ethnicity, My Veteran Status, My Mental Illness(es) and my speech impediment. Also is GUILTY of FAILING to Investigate allegations and FAILURE to investigate reports / accusations of CHILD ABUSE that is Clearly Stated in Police Reports / reports, and Photos of text messages sent to my wife on

Those Reports have been right in front of her for Almost now. NOTHING!

- Public Defender is guilty of failing to report my suicide threats / attempts Multiple times! Failure to protect / ensure the safety of a fellow County Employee Prosecutor Failure to provide the State Critical Evidence I sent her multiple times that would of proved my innocence! I sent her numerous letters, emails, texts, PROVING my innocence on All Alleged Charges and she didn't relay ANY of it to the STATE AT ALL! She is also Guilty of FAILURE to investigate allegations, and reports of CHILD ABUSE on going for Almost now! It's in the Police Reports / reports and Photos of Text messages, that were ALWAYS right in front of her, on her desk for the entire Year of

Important things to point out

1) - Why is my wife listed as a "victim", when it states multiple times in Police Reports / Lethality Report / Order of Protection. said that never assaulted her or the kids " stated she did not hear make any threats towards her or the kids " did not see with any weapon at all " ? Now please Read the Lethality Report and Carefully Read the Order of Protection. Anyone will conclude that I, in fact Never was a threat to anyone. Now please read the Photos of the text messages sent to my wife, that was "supposedly", "possibly", "allegedly" in a threatening manner. It stated by me via text "I'm going to call Police on you to have you arrested, and and show them both Photos, Video, Audio of you abusing my kids." It can also be found in the reports multiple times as well. I disclosed to on duty Officer while in the hospital, and my former counsel that I was in fact assaulted by my wife during the verbal argument. I was struck in the forehead by a 9-volt battery thrown by my wife causing physical injury. (See backing photos please) Nothing was done at All. later. Nothing. I don't want to press charges anymore, Anyway!

2) - Why is my son listed as a victim as well? In the Police / reports / Lethality Report / order of Protection it states multiple times that " never saw with a weapon at all " did not hear make any threats to anyone " did not see assault anyone "

3) - Now it lists my daughter as a victim as well. It states that I pulled her hair, and saw me pull her hair, when she jumped off the top bunk. I in fact DID pull her hair. I pulled her hair "loose/ free" from being caught in between the metal bed posts
