ORDER

April 24, 2020

The Complainant alleged that a superior court judge improperly issued and upheld an order of protection against him and that a superior court commissioner failed to give him a fair hearing in his divorce case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Dear Commission of Judicial Conduct,

I have a conflict with Judge [redacted] is
Honorable Judge [redacted] and Honorable Judge [redacted]

The conflict I have ^{with} Judge [redacted]
is that she signed an order of protection
with no proof or reasonable cause... My wife made
up some stories to prevent me from seeing my son while
we were going through a divorce. I didn't know I
wasn't allowed to call my wife? These accusations
are false and there is no proof saying otherwise.
I was not given a fair hearing on [redacted] the
day this order of protection was. I was not
given a fair hearing until [redacted]. When I
had a fair hearing the judge already had a
biased opinion of me. She said I look like I
have no regard for human life. The man my
wife was cheating on me with made false
allegations involving a different case that I
have not been convicted of and am fighting
in trial. I'm innocent until proven guilty. Anyway,
the man that [redacted] my wife was cheating
on me with shot me [redacted] times with a .45.
I didn't hurt anyone I said that I wanted
to see my son. That's all I wanted to do

I just wanted to see my son. Judge is not a custody or family court judge and seems to think that now she is not in charge of drug court or criminal proceedings that she can ruin whole families lives now! It's not right! She should not be a court judge in anyway! She has no right to say I can't see my son or take away my 2nd Amendment rights based on allegations! The judge believed someone who tried to kill me over my statement with no proof or reasonable cause. She refused to order of protection or let me see my son. Because of allegations and other charges that I'm fighting while awaiting trial. She made speculations, bias opinions, prejudice and did not apply the law in anyway. According to Arizona code of judicial conduct Arizona Supreme Court Rule 81, canon 2 Rule 2.2 the judge was impartial, was not fair, or open-minded. She did not act in good faith. This judge has a pattern of legal error and complete intentional disregard of the law. The evidence is on court record from Rule 2.3 was also violated by a Bias, and Prejudice opinion of me. Judge also

allowed my wife's lawyer to manifest bias and prejudice character judgments against me by presenting other cases that had nothing to do with court proceeding.

These issues threatened my character, stereotyped me. Judge made derogatory statements and facial expressions that were demeaning and caused me serious emotional and psychological injury. This judge had no regard for her conduct and did not even take into consideration my side of the story. I will be taking legal action against Judge by

Civil Lawsuit with the District Court.

According to Rule 2.5 I don't believe this judge is competent she did not dispose of matters efficiently and did not resolve any issues with the matter at hand. Also, did not try to reduce or eliminate dilatory practices.

The issues I have with Honorable Judge was that he ruled in divorce court without giving me the chance to a fair hearing. I sent a motion that was hand written and can't be typed. He defaulted dissolution of marriage without a hearing and

did not take me into consideration. I wanted to file lawsuit for infidelity against my wife for committing adultery with another man. while we were married she tried to get order of protection so I wouldn't get in the way of her affair that she was having and keep me away from my son to hurt me she fake cried to gain sympathy from the judge and the judge believed it! I sent letters and motions to judge with no access to my bank account I could not obtain a lawyer or file divorce papers with court because I'm stuck in jail on a cash only bond that I can't afford I explained everything to judge and all letters and motions were sent back to me. Stating that I needed to pay a fee to be taken into consideration even though I'm in jail awaiting trial... Giving my son my now ex-wife full custody of my son while I get no say in proceeding and wouldn't give me a fair hearing! These actions need to be overturned and I deserve a fair hearing! All these events took place at the court in the court and court. something must be done!
