**ORDER**

April 9, 2020

The Complainant submitted a complaint that failed to articulate a discernible act of judicial misconduct.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Gus Aragón did not participate in the consideration of this matter.

**How can I report extortion by a family court judge?**

Community Answer

Try the Commission on Judicial Conduct for your state. Anyone can file a complaint against a judge. You do not need a lawyer.

**My ex-wife is threatening to send me to child support enforcement if her alimony demands are not met. I have always supported my daughter. I have receipts. This would cause me to pay for another attorney and threatening to contact my job about a car loan that she defaulted on. Is this extortion?**

Community Answer

The best step is to consult a criminal attorney. There may be laws on the books in your state that will protect you. If you have receipts and signed legal documents that show your obligations under your divorce agreement and receipts that show your adherence to these stipulations, I would think she could be charged with something. Please consult with an attorney to protect your legal rights.

**How do I handle harassment?**

Community Answer

Talk to the proper authorities. If it's happening at work, go to your boss or the human resources department. If it's happening in your personal life, talk to the police.

**Who do I report blackmail and extortion to?**

Community Answer

Blackmail and extortion are serious offences. If there is immediate danger involved, a 911 call needs to be placed. If there is no life threatening situation, make a non-emergency phone call to the local police. All evidence, such as voice messages and text messages, must be included when filing the report.

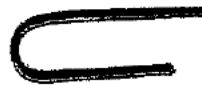
