ORDER

May 21, 2020

The Complainant alleged that a superior court commissioner issued improper rulings in a probate matter, was biased in favor of the opposing party, and facilitated thefts of family property.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Colleen E. Concannon did not participate in the consideration of this matter.

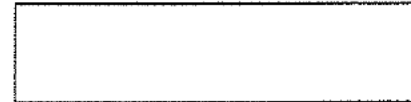

 CALLED _____ CTY SHERIFF'S OFFICE ABOUT THE VAN AFTER HE FOUND IT AT
 TOLD HIM, THEY WOULD DISPATCH A DEPUTY TO RECOVER THE VAN,
 BUT THEY NEVER ARRIVED. MY DAD WAS FOUND BY THE PARAMEDICS TO STILL BE ALIVE BUT
 NOT BEING TAKEN TO _____ HOSPITAL, INSTEAD HE WAS TAKEN TO
 A NUMBER THAT _____ HAD CALLED HERSELF. _____ WAS FOUND TO
 HAVE STOLEN MY DEEDS AND CORPORATE DOCUMENTS WITH MY MOM'S JEWELRY
 ACCORDING TO THE PARAMEDIC MY DAD WAS STILL ALIVE.

I WAS DENIED ANY ACCESS TO INFORMATION. MY PARENTS HOUSE WAS LOOTED AND ACCORDING TO _____ AND _____ ASSOCIATION, THE HOUSE WAS EMPTY THE FIRST WEEK.

I HIRED _____ ATTORNEY ON _____ RETAINER \$ _____, WHO FAILED TO LISTEN ABOUT THE ILLEGAL USAGE OF THE SIGNATURE STAMP THAT WAS USED ON MY DAD'S ADDENDUM AND ON THE FINANCIAL FREEDOM CASE. _____ REFUSED TO LISTEN ABOUT THE COURT ORDERS OR THE BURGLARY THAT HAD TAKEN PLACE. _____ WAS DISMISSED. I NOTICED THAT MANY ASSETS INCLUDING INSURANCE POLICIES AND MY PARENTS RENTAL HOUSE WAS NOT LISTED ON THE TRUST ASSET SETTLEMENT LIST. MY PARENTS AND I WERE CLOSE. I TRIED TO TELL _____ ABOUT HOW MY PARENTS WERE CONTINUALLY BEING SWITCHED TO DIFFERENT DOCTORS, AND HOW THEIR MEDICAL RECORDS WERE DISAPPEARING FROM THE DOCTORS OFFICES. THE DOCTORS HAD TO START NEW FILES DUE TO THESE SITUATIONS. THE APPOINTMENT WERE A WEEK APART FOR MY MOM. WHEN _____ TRANSFERRED ME TO HIS ASSOCIATE WHOM REFUSED TO LISTEN, _____ WAS DISMISSED.

I RECEIVED MORE INFORMATION FROM _____ AND I RESEARCHED ABOUT THE ADDENDUM. I FOUND THAT _____ WAS THE PERSON WHOM WAS A DOCUMENT PREPARER THAT WAS DISBARRED IN _____ AS AN ATTORNEY. I REMEMBERED A PERSON THAT I KNEW NAMED _____ MY MOM'S ATTORNEY, AND I CALLED HIS OFFICE. I WAS NOT ABLE TO TALK TO _____ EVER BUT WAS TRANSFERRED TO: _____ I FOUND OUT LATER IS _____ SON. _____ STARTED OUT OK ASKING FOR A LIST OF ASSETS AND FOR INVENTORIES FROM _____ OFFICE. I PAID A RETAINER ON _____ TO _____ TO HANDLE THE CASE. ONCE AGAIN, IT WAS FOUND THAT NO INVENTORY HAD EVER TAKEN PLACE. I DID TRUST ACCOUNTING UNDER _____ AND AM FAMILIAR WITH THE CLOSEOUT PROCEDURES AND VALUATION. _____ RECEIVED THE RETAINER AND FORGOT TO SEND OUT THE LETTER OF REPRESENTATION UNTIL AFTER _____ BY THAT TIME, _____ WAS REGULARLY CONTACTING ME AND SHE REFUSED TO CONTACT HIM DIRECT. I ASKED _____ TO ORDER THE PHONE CONVERSATIONS OF MY PARENTS AND I. HE NEVER DID. THEN I ASKED HIM TO GET THE BURGLARY REPORT AND HE NEVER DID. SO _____ WAS DISCHARGED ON _____ THAT IS WHEN I FOUND OUT HE WAS _____ SON AFTER I RESEARCHED AND RAN BACKGROUND CHECKS ON BOTH. _____ WAS ASKED AND HE DENIED IT. I HEARD RUMOURS THAT HE HAD STAFF RELATED TO _____ ACCORDING TO WHAT I WAS TOLD _____ WANTED THE CASE SETTLED AND REFUSED TO GET A SIGNATURE ANALYST. HE REFUSED TO CALL _____ TOO.

NOW I AM FACED WITH AN ATTORNEY THAT IS GOOD FRIENDS WITH THE JUDGE. I CANNOT FIND DECENT REPRESENTATION AND AM STILL LOOKING. I SUBMITTED THE FILING FEES AND THE MOTION FOR OBJECTION FOR THE TRUSTEE SINCE IS AN ADVERSE PARTY ON AND FOUND OUT LATER THE CASE WAS NEVER ENTERED AT THE CLERK OF THE COURTS OFFICE. I RECEIVED A SIGNATURE ON THE PACKAGE WHEN IT WAS RECEIVED BY THE PROBATE SECTION OF THE CTY COURT IN ARIZONA. I WAS TOLD THAT WAS FOUND WITH THE PACKAGE HERSELF AND HAD FAILED TO ENTER THE DOCUMENTS INTO THE CASE INFORMATION AS IS REQUIRED. PACKAGE WAS LOST IN THE MAIL AND I HAD TO EMAIL IT TO HER OFFICE WITH THE OK OF HER OFFICE ASSOCIATE. THE USPS TRACKING NUMBER IS N TIME FOR THE CLERK HANDLING.

I SENT A MOTION TO CONTINUE IN TIME TO BE RECEIVED BY THE CLERK OF THE COURT AGAIN, THIS PACKAGE WAS SENT VIA FEDEX AND WAS ILLEGALLY REROUTED BY MISTAKE TO INDIANAPOLIS. THIS PACKAGE WAS TO BE RECEIVED BY I PAID ADDITIONAL FEES. FEDERAL EXPRESS SAID THEY FINALLY DELIVERED IT TO THE COURT ON AT IT IS NOT MY FAULT THAT FEDERAL EXPRESS MADE A MISTAKE. I WAS TRYING TO GET THE PACKAGE THERE EARLIER BUT OFFICE FAILED TO RESPOND UNTIL AFTER WHEN THEY WERE CALLED AT I WAS TOLD BY THE SECRETARY TO JUDGE TO GIVE A CHANCE TO RESPOND BEFORE EMAILING THE MOTION TO CONTINUE INCASE SHE REQUIRED IT TO BE MAILED.

IN SHORT I WAS DENIED ACCESS TO THE HEARING. I WAS FORCED TO LISTEN TO THE RECORDING OF THE CTY GOVERNMENT SITE INSTEAD OF BEING INCLUDED ORBEING MUTED.
