The Complainant alleged that two superior court judges violated his rights.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Roger D. Barton did not participate in the consideration of this matter.

It does not reflect IN ANY MANNER the events of the case. The _____ witnesses don't agree with them. But they still are pushing this case.

They are still doing me harm with this case. It is based on fabricated lies.

I had a lawyer try to provoke me to cause violence over and over, instead of working this case. He doesn't remember the statement I made that caused to question my sanity and pursue three Rule 11's. He still doesn't remember what I said. He must of been rising to commit the work for the Prosecutor's Office.

_____ has had a history of defense denials. I am on the law books for their allowing the _____ to prosecute a felony for a misdemeanor. I went to prison for their lies. The entire case is based on lies. I _____ denied access. (He also skated any harm, as the Bar attacked me when I filed my complaint.)

A lawyer that never talked to me, told me she doesn't contact her clients (" _____ ") and bumbled a hearing and nearly had me miss Court. There was no notification for the date _____ which has never been declared or posted for the arrest warrant issued by _____ I was illegal arrested and detained. This case is based upon that fraud.

When _____ Police Department arrested me, they didn't want to do so. They said that the caller was incorrect in every way. When I asked them about the "Accuser," they denied my right to face my Accuser or to address the call. Another illegal maneuver and denial of my rights. A continuing factor in this case and in history. I am always under selective prosecution here in _____ County. I have case history in the "law books," over their repeated refusal to follow the law and my rights. When the call finally was verified as a warrant from the _____ Police apologized, as they didn't believe there was a warrant over this case. So they took me to jail. The Judge felt insulted when I made the Motion, the Clerk verified my Motion and my statements as factual, with a "he's right your Honor. The Judge didn't dismiss the case. The Judge continued the OR bond and then threatened me with \$25,000.00 bond, if I didn't show up. This also derails _____ case as the higher bond, which also violates my rights under the United States Constitution, was not held. It was the \$5000.00 bond, without factual basis. I was released. And with no further incident, although _____ continues to trap me. Using "the rapists to snitch out jay-walkers" tactic. That also are mountains of evidence that proves my innocence, that _____ is hiding. (The reports made by investigators, ie the _____ Public Library.) They went around investigating me with locals and found that I am not the person they are accusing me of being. I do not fit any of their lies. My profile defies them. They lie, a typical and well-know tactic of the Arizona Judicial Elite.

It isn't my job to prove _____ case, it is their job. They don't have a case, they are promoting Communist's tactics that violate the laws to trap me into a plea or other avenues. The _____ is again complacent to these violations. It is well-know Arizona is not going to pay for a legitimate defense in their State. They don't promote the law or its education, they hide it ILLEGALLY.
