ORDER

The Complainant alleged that a municipal court judge lacked jurisdiction to hear and consider his case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Christopher W. Ames and Delia R. Neal did not participate in the consideration of this matter.

- COURT never proved Jurisdiction over me on the record so the court could not proceed without proving it first. "The Law provides that once the State and/or Federal Jurisdiction has been challenged, it must be proven" Maine v. Thiboutot 100 S Ct. 2502 (1980)
- I nor () the corporation was never obligated to appear (formally submit myself to the court) to court because I

never signed the traffic ticket and I don't have any contracts with the STATE OF ARIZONA.

 The court denied me Due Process of Law to obtain a default judgment in the name of the legal fiction to illegally and unlawfully "

" before I could contract with the STATE OF ARIZONA to obtain a Drivers License.
