ORDER

The Complainant alleged that a superior court judge was biased and made incorrect legal rulings in her case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Christopher W. Ames, Joseph C. Kreamer, and Delia R. Neal did not participate in the consideration of this matter.

Her focus has always been what is best for the children and wanting them to know and have contact with their father. In this most current incident when her partner took their children from her she realized he exploited the very thing she was trying to provide for him and the children; contact and a relationship. As she is serious about ending the relationship with him, the only way her partner has to control and hurt her is through the children. That he is using that tactic is disturbing enough, much less that he is trying to use the court system as a tool in this endeavor is terrible but oh too common. education and has prioritized that with the children. They have had exemplary school attendance, even with the challenges of the pandemic and, up to the point when her partner took and is keeping the children from her. She has shared when the children were taken, her partner did not have the children's identification so they could not attend school wherever they are. In addition, he has continually harassed her this whole time and even tried to get thousands of dollars from her and says when she pays he will return the children.
