### **ORDER**

## February 24, 2022

The Complainant alleged that a superior court judge denied him "fairness and safety," refused to hear his allegation of sexual assault and domestic violence, and refused to address statements made by the opposing party's counsel.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Delia R. Neal did not participate in the consideration of this matter.

By not allowing Respondent to submit evidence, has greatly impaired Respondent's right to a fair trial.
Further inaction regarding Respondent's multiple pleas for help has not only contributed to an ongoing abusive environment, it condones it
