The Complainant alleged a justice of the peace was biased against her and failed to recuse based on a conflict of interest.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Denise K. Aguilar, Roger D. Barton, Joseph C. Kreamer, and Christopher P. Staring did not participate in the consideration of this matter.

I understand Judge has infact done this kind of thing before in the past . And further found guilty by Judicial Conduct Commission of Az . At trial under Judge it was revealed that Judge helped the write her paperwork for the injunction order . By witness for the State and in the Court record .
