ORDER

The Complainant alleged that a municipal court judge incorrectly ruled on her matter, denied her constitutional rights, and had incorrectly calculated her fine/fee.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Delia R. Neal did not participate in the consideration of this matter.

Out of here the two went back in side I gathered my bag from the table outside and when I walked past the store door I opened it and told him I was leaving but that I would be talking to his boss the county attorney said because I opened up the door than I was guilty I agreed but just recently I have been spending a lot of my time researching and I found that the charge I plead guilty in fact I am not guilty at all the law states when a person is asked within a reasonable manner and stays on the property after a reasonable quest is guilty of this charge within reason would be to ask without any extra effort in a calm cool collective respectful way not in the way the man over exerted himself while slinging his arm around this was unfare I plead not guilty and was some how cheated out of the representation needed to win the judge has edited documents and changed online information and provided incomplete information about me on a back ground check that later ended in being fired from my job in of I was arrested and suffered multiple serious injury's
