The Complainant alleged that a superior court judge ruled incorrectly in the underlying matter.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Denise K. Aguilar and Delia R. Neal did not participate in the consideration of this matter.

My daughter has been showering with and sleeping with a nearly , the child of my ex wife's roommate. My ex-wife is named , and her roommate is named . I confirmed the older minor was actually in the shower with my daughter, , not simply helping her bathe.

This situation is, at best, wildly inappropriate. At worst, one or both of my daughters is being molested while at house. My older daughter. , stated that she does not sleep with or shower with the older minor. I have retained custody of the children against the parenting plan. Judge did not give me emergency temporary custody, because apparently she thinks this situation is completely above board and there is nothing to worry about. I want her removed from her position immediately for attempting to put my children back into an abusive situation and making me violate the law while protecting them. This is simply an outrageous situation, I am going to lose thousands of dollars, maybe my children and maybe my freedom because Judge is incompetent.

set a date of to discuss the matter with no changes to the parenting plan, as stated. If there is some sort of molestation going on, which is not unlikely given the nature of the situation, would have the sexual assaults continue. This is a staggeringly dangerous decision, I will not send my children back to a place where they may be getting assaulted.

I am contacting the media because of the complete lack of response that I've gotten from the courts, Police, and the hilariously named Department of Child Safety. I am planning to sue, and to make this situation extremely public. I don't think the general population of Arizona will approve of the actions and inactions that have been taken, putting my children and myself at risk.
