ORDER

March 30, 2022

The Complainant alleged that a municipal court judge assaulted him and tried to kill him.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Christopher W. Ames and Louis Frank Dominguez did not participate in the consideration of this matter.

I was only able to detect a little sound on my right shoulder and after that I woke up on the

While in the Hospital, I received telephone calls from the detective _____ where he told me that it was big names on the attack, but I never got those big names.

On his last call he told me the names was down to _____ and that the incident was not an assault but an accident.

Of course, I never got the _____ big names that assaulted me, and the _____ people testifying in regards the accident at an over the phone hearing, verify my worlds by their own statements.

The damages I suffered are devastated and yet to be taken care.

They broken my Pelvic (today I got a steel rod installed from the right to the left side to help me walk).

They broke my right arm and the surgeon instant of fixing it broken additional bones on the wrist with the screws she used in order to attach everything together, leaving the hardware inside my right arm along with the broken bones, making it impossible to fix it.

They broke my right shoulder, while they were moving my body from the side walk (where the beating took place) to the street, in order to call it an auto accident, and also during the movement, while they were dragging my body on the gravel, my rear end was heavy wounded from the side walks gravel.

Also, while the movement one of the offenders was pulling me to the side walk by a pitchfork, the other one grasped me from the right shoulder dislocating it and the same time terminating the blood's supply to the brain causing my death.

I was brought back to life _____ minutes later on.

According the Physician _____ my shoulder is not fixable, also I got problems with my ligaments and sciatic nerves as of it, making the effort to walk a big deal, which worsens every day!

The first hit I received to the right side of my face and head, that knocked me out, made it painful to chew on the right side, everything is soft and painful in there.

My condition is critical and the wounds I safer require time in order to take care of them.

In that order I asked twice the judge to respect the Law of Arizona as it mandates and give me life time to file a law suit in order to get relief for what they caused on me.

I was never given by the Police department the _____ big name offenders, on my request to get the names they told me it was not possible as a result of the protection!
