ORDER

The Complainant alleged a superior court judge entered a mental health evaluation order in violation of the law.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Christopher W. Ames did not participate in the consideration of this matter.

I am writing to file a complaint against judge .
 signed a hour mandatory evaluation, granting officers and a team
the right to come to my home and force me into a institution.
At the institution I informed the doctor, that I was a business owner and I was being
harrassed by what I suspected to be corrupt local law enforcement. I let the doctor know that I
recently reported the harassment/corruption of law enforcement to the . Having me
committed to a institution was nothing more than retaliation, a way to make me go
away and/or discredit me.
After explaining to the doctor in the mental institution, the harassment I was enduring, and
events that caused me to suspect law enforcement corruption as well as everything that
transpired from there, the doctor said, it was clear I did not belong there. I was then
discharged early with a clean bill of mental health.
After being released I consulted an attorney. One of the things the attorney informed me of,
was even if the statements made in the court order presented to the judge were true, the judge
NEVER should have signed off on the court order. Apparently none of the statements, even if
true (for the record they are not, police det lied) did NOT meet the
criteria necessary for the judge to grant the order.
I wondered if the judge had become complacent in her job... or, if she did not know her
job...or, if she was involved in the corruption.
I went to the county building to speak with the individual who was my "court appointed
attorney" in regard to the case. That individual was on vacation so the security guards at the
desk offered to help me by getting another attorney on the phone.
I was put in touch with attorney who asked for my case number. After I gave the
case number attorney immediately began yelling at me. Ms. stated (and I will
quote her)
I thanked attorney for her assistance and hung up on her while she was still yelling at
me. The security guards were standing close enough to hear and commented
. I agree.
Because I took attorney threat seriously, I have hesitated to file this complaint. I did
not want a team showing up at my home again. Also, my husband knew of corrupt law
enforcement and shortly after his discovery, his body was found in the desert here in at
. His death certificate states cause of death blunt force, ruled an accident,
case closed...highly suspicious.
All of this happened between , but I am still being harrassed to this day. Therefore,
I have decided to send this complaint to you, as well as contact the in and several
other entities.
If due to the time lapse, you are not able to look into this situation, I do understand.
