**ORDER**

July 7, 2022

The Complainant alleged a superior court commissioner treated her disrespectfully during a family court proceeding and was biased in favor of the opposing party.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Christopher W. Ames and J. Tyrrell Taber did not participate in the consideration of this matter.

Hello:

My children and I are victims of domestic violence and County courts continue to enable abuse upon my children and myself. Since our first court hearing I've asked for supervised visits, I've also inquired about several order of protections due to escalating behaviors by My children have never lived alone with him, we've never been married, and the only reason this is in family court is because took our children after verbally attacking me and coming close to physically harming me in front of our kids. He continues to go against all legal orders and is posting family court matters online.

- 1) All documents for this trial were not entered as pieces of evidence and all children's medical records were submitted but not added to the docket
- 2) On Commissioner mocked me for submitting school records. She informed she'd be entering them but didn't see what that has to do with him being a danger.
- 3) Both hearings in which I attended, I would always address Commissioner in video and then turn off the camera after speaking because of my fear that would do, exactly what he's done, post it online. At the second hearing, she yelled at me to keep my camera on. I totally did not know it was unacceptable, I was just trying to protect myself because I never want my children to suffer seeing us exploited online.
- 3) I did not get my full minutes to present, as used many of my minutes to detail fabricated stories, in an effort to manipulate the courts. If you review the hearing he was not talking about the best interest of our children and was actually given time to fabricate stories about other children.
- 4) agent reached out to your courts directly, to provide information to the judge regarding. He was denied an email or contact info by the admin in the Commissioners courtroom. Eventually someone else provided him with the online submission information.
- 5) I attempted to enter fraudulent welfare obtained by along with a previous and she denied me that opportunity too, although it sheds light that continues to weaponize with my children for financial gain and coercive abuse and also confirms troubling accusations my kids have mentioned since returning home after our initial trial on. While in informed my kids to lie about abuse and told them, he could get a month for each of them if they lied. This was my reasoning for wanting to submit evidence of weaponizing my children for fraudulent financial gains. The school records were to represent their stability and school support and praise by administrators, since being back under my for months.
- 6) In the screenshots of the trial posting posted online, you will also notice at least several people in attendance. During our last hearing, Commissioner informed me, that she would allow me to know whose present in the hearing and that did not happen.
- 7) Finally, Commissioner accused me of trying to pull a fast one to change court orders and I'm actually just trying to protect my children. refused to speak to my children for several months, and I even asked the judge if I could submit documented proof of this by PD and she stated no. He would make false reports to PD about not having contact with our children and they informed me to seek an order of protection and to continue documenting.

has stated he has nothing to lose in the past year and how cops can not protect us. He has now shown up to trials without proper documentation and work history and these cases need to be evaluated. He is unstable and I don't know what else can be done to protect my family. He talks about killing my family and booming people who may have commented to take personal court info down.

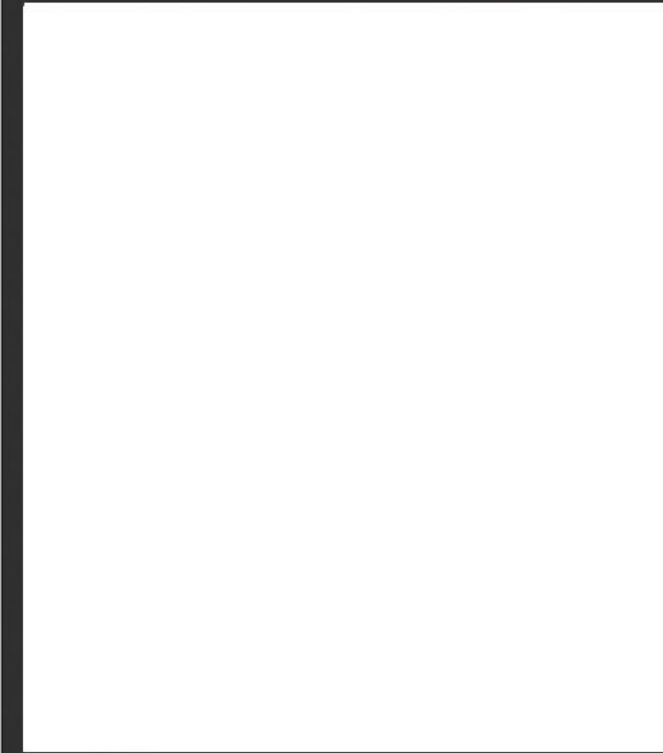
While the judge said she saw no reason to change orders, she mentioned it would go under advisement. Over people were given access to personal family court hearings on alone and although removed it, I am not sure where or how many times it was shared but this is a determinant to my children, their safety and well being.
