The Complainant alleged a superior court commissioner was rude and unprofessional toward him during a family court hearing.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Colleen E. Concannon and J. Tyrrell Taber did not participate in the consideration of this matter.

SHE YELLED AND RAISED HER VOICE AT ME IF I HAD AN OBJECTION TO SOMETHING THE OTHER ATTORNEY WAS TRYING TO ADMIT INTO EVIDENCE.

SHE WOULD YELL AND RAISE HER VOICE AT ME WHEN I HAD A QUESTION.

SHE WOULD INTERUPT ME WHEN I WAS TESTIFYING AND RAISE HER VOICE AND MAKE RUDE COMMENTS.

AT THE END WHEN I WAS GIVING MY CLOSING ARGUMENTS - AGAIN SHE FELT IT NECESSARY TO INTRUPT ME AND CHASTISE AND BERATE ME FOR WHAT I WAS TRYING TO TELL HER.

SHE EVEN STATED THAT SHE IS NEW TO JUDGE - SHE IS HARSH, RUDE, AND COMPETELY UNPROFESSIONAL. I FEEL SORRY FOR ANY MAN OR MAN WHO ENTERS HER COURT ROOM REPESENTING HIMSLEF.

I LOOKED UP THE QUALITIES OF A GOOD JUDGE: JUDGE LACKES ALMOST ALL OF THESE QUALTIES WHEN I WAS IN HER COURTROOM.

Judicial Temperammet: This character trait encompasses bot the ability to apply the law to the facts and to understand how a judicial decision will effect the human beings appearing before the court. It is the ability to communicate with counsel jurors, withness and parties calmly and courteously. Aspects of propert judicial temperament - Patience, open-mindedness, courtesy, tact, understanding, compassion, humility and common sense.
