ORDER

February 8, 2023

The Complainant alleged improper and illegal rulings by a superior court judge hearing a family court case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Michael J. Brown and Joseph C. Kreamer did not participate in the consideration of this matter.

This judge showed so much impropriety and blatant contempt for me as he berated me at beginning until the end. By the egregious things said and done but mostly the things that were written in his order it was obvious he too had been paid off to get on the bench to say i was uncredible and grant relocation of my child away from me. Miss made it quite clear she knew him on a personal level. ExParte seemed obvious as she brought a to have me arrested that day but an hour into trial the judge called for a recess to tell him that would not happen that day. Thank God i had witnesses or i would have been incarcerated. My ex got on the stand and arrogantly admitted perjury and contempt and said he was in control yet the judge said nothing. The order he took almost to file was as erroneous as it gets. Disregarding my evidence of the last order that said i was allowed to attend school events. In the order he wrote made me in contempt for it, then saying i scribbled a message to my son on the sidewalk, on my childs first day of school. He also wrote in his order that he did not understand why i had not done a evaluation that costs up to and the pandemic was no excuse coming from a guy that has tenure and not effected by it. Not accepting a evaluation i had done with a reputable servicethrough my state medical insurance that Miss lied to him that it has been rejected as legitimate. Other comments made of me lingering in my neighborhood park with my dog but mentioned it was my exs neighbourhood not mine as i live just blocks from my ex. So my child could feel secure to go back and forth and feel comfortable about the trauma of the divorce. He also made statements about a situation where i confronted my exs step father who molested my child according to a forensic interview done. I spoke n without cussing and drove off. He was told i tried to run him over and clearly by the video i did not but Miss and his lawyer are running around slandering me saying i did, she called the incident in as a with a I plead guilty to so i thought i did not know it was considered a on top of it. Thats a whole nother issue im fighting to make right. My ex claimed he was a victim using the system to strengthen his case. The reality of it was this Judge jumped on the bench to label me a liar and grant the relocation and jumped off the bench as he served his purpose. The things he spoke of and wrote about was clearly hearsay as the courts have never looked at my evidence of the my child is enduring. Speaking for my child like he knew or talked to him. Which my son did deserve a voice and mentioned several times disturbing things during my supervised visits that was never looked at or considered. Now he is living with the man the man non blood relative that DID him and paid for the lawyer who covers it up. I used to believe in the justice system to be fair and at least hear all evidence but not so much anymore. Equalization of the law has never happened and Best Interest of our child was clearly for Dads best interest as even my witnesses observed to be the factor. He talked about his daughter and how fast they grow while robbing me of my liberty of the child i spent so much time with being class mom and chair. As i did not get to do that with my other kids because i had to work jobs to raise them. The judge also applauded dad for having the child in which was my idea in the first place but only had sessions under strict supervision at fathers on the computer. Now in says he doesnt need it. I know my and i guarentee he is devastated as we never got to hug and say goodbye to eachother. Judge did not apply a parenting time plan for my son and I to have a frequent meaningful set time as required of him to do. Therefore i have been erased from my childs life since He was gone by from his home state with no prospective of seeing or talking to his mother again held from doing so by a malicious parent swinging on his mothers purse.

Even medical issues that are all pointing to a [redacted] that is not being followed up with [redacted] asked me if i thought it was an [redacted] as shocking as that is did not investigate to make sure. The Judge also mentions [redacted] the Judge [redacted] ordered that never met me yet makes recommendations in our case about me. She met with father and they paid her, a recommendation that should have been thrown out for biased and payment for her opinion to be for father. Judge [redacted] started the ball rolling but Judge [redacted] was obvious in his contempt for me and Impropriety does not even cover the outrageousness of his actions. I am mostly shocked that they do not take responsibility if he is wrong. You would intelligently think that if a person is making a major desicion in a childs life they would take all considerations about his future and not let my child be taken [redacted] away out of any security he had and the eyes of the parent that would protect him with all due dilligence. I am now unfunctionable because i did not save him from the abuse he spoke of and was documented even talking about wanting to see God drawing pictures of how he felt that was ignored. This Judge being so new to the bench was not impartial or fair and in [redacted] and a [redacted] made assumptions about me and what was best for my child that was not right at all and berated me as a bad parent that is obvious in jis order. So my ex could glorify himself while telling every authority look the judge says she is crazy and a liar to discredit me to them and my child. This is atrocious to say the least and listening to the trial and the things that wrre said was a mochery to the judicial system. [redacted] of [redacted] i had good credit, reputation, active in the community and always there on a dime for my child. In little under [redacted] have missed milestones with my child i can never get back, in debt over [redacted] fighting criminal charges put on me by a clever lawyer for spiteful accusations as Miss [redacted] put it in her letter as me, and i dont know if my child is dead or alive or if i would even be notified of it or if we will see eachother again as my ex deprives his son as a mother he is not allowed to talk about yet runs home to live with his. Judge [redacted] also ignored the fact my ex lied and said he could not afford childcare when he owes nothing on his house and truck making [redacted] dollars an hour as a [redacted] since no one hires someone as a [redacted] that can not pass the [redacted] evaluation required for a paramedic to work with the public. Our case is so egregious that i have only stated a quarter of the shocking facts and acts in our case niether of our judges seemed to have ears open to. For that Best Interest factor but Judge [redacted] did the most damage to my childs future by granting relocation [redacted] away.
