The Complainant alleged racial discrimination and improper rulings by a superior court commissioner hearing a family case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Colleen E. Concannon did not participate in the consideration of this matter.

Has repeatedly demonstrated bias based on my race (______, disability, and veteran status

Has repeatedly ordered in the Respondent s favor even after presented with concrete evidence of her criminal activities, perjury, and parental alienation tactics

Credited the Respondent on the child support work sheet for her travel to the boy schools, however did not afford this same credit to me when I had to travel for their school after Respondent moved without filing a request for a change of address with the court

Has never required the Respondent to submit paystubs, bank statements, or any verifiable source of her income

Attributed extra income to my income even though I am a and Failed to attribute extra income to the Respondent even though she is choosing to work less than full time and failed to report her multiple businesses including income.

Has never required the Respondent to provide the income made by her multiple businesses even after presented with concrete evidence of their existence

Stated he made a mistake when attributing extra income to my income because he confused me with his other case with a and then ordered arrears based on his own error

Originally stated he was making the arrears because of his mistake and because we proved Respondent was lying about both her income and her child care costs and then changed his minds years later at Respondent s request and her personal excel spreadsheet

Ordered arrears be paid to Respondent even though the stated there were no arrears and the case was closed and the s office stated they did not see any arrears

Ordered Respondent can claim the children for even though the child support order says differently and I was never given any relief from tax credits when I was paying child support off the order he made an error on

Ruled the Respondent can claim both children for when there are significant child credits. Failed to consider that Respondent and her husband make too much money to qualify for these credits against the child support guidelines that state the credits should go to the parent that qualifies.

Ruled I have to pay federal and state taxes based on fees and fines based on tax fraud committed by the Respondent. Ordered it was my responsibility to fix the fraud she filed on a return and my responsibility to get her money back that was garnished due to her fraud. Failed to consider she is pending federal and state tax fraud charges even after I told him I have an upcoming appointment with an investigation on

Ruled in that my child support obligation be set to did not back date it to my filing date of and has not credited me the money that was paid to Respondent until

Has failed to rule on my original motion to change parenting time and legal decision making filed in of after Respondent took my children to the police station on and tried to force them to say me and my wife them.

Has made it a priority to rule on Respondent s motions for school choice and monetary awards for no apparent reason even though they were made after my motion to change parenting time and legal decision making

Zeroed out Respondent s duty to pay child support even though she makes significantly more money than I do and I have to pay for one child to attend school and the calculator states she has to pay month

Ordered I pay the Respondent money based on her own personal excel spreadsheets that are not based on any factual evidence and failed to take into consideration my calculations

Ordered the Respondent have presumptive medical decision even after presenting her failure to provide basic medical care and refusal to provide care that costs money

Have never held Respondent in contempt or sanctioned her even after presenting concrete evidence of her multiple false and reports and withdrawing the children from school

Has failed to actual consider what is in the best interest of the children and now at least one of my children has to be held back in school because he refuses to make a decision on my original motion, allowed the mother to withdraw my children from their previous school, and has allowed the Respondent to waste everyone s time with false accusations and false money requests

Never required the Respondent to submit a change of address request even when it meant the children would have to change schools and when she moved to a completely different county

Required me to drive the distance to make up for the fact that the Respondent chose to move out of county

Claimed to not be aware of parental alienation tactics the Respondent was using even after presented with a report stating she was coaching the children

Never required the Respondent to submit her ordered I had to do so Forced my wife to modify an records or her bank statements but
