#### **ORDER**

#### December 14, 2022

The Complainant alleged improper rulings by a superior court judge hearing a family case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Colleen E. Concannon did not participate in the consideration of this matter.

Our son recently moved to to live with me back in due to issues he was having with his mother. Our son is thriving in his new environment, and the mother has only seen him once for a few days since In the months time since the order was put in place, I have taken our son to the dentist twice, a counselor at least times, spoken with his teachers, taken him to see a over an away from where I live, and have taken him to his times, as well as taken him for an exray for possible I work a full time job. Despite this, the judge and attorney stated I was not putting enough "effort" in. I feel that since I was representing myself, the judge did not listen to me, and gave me few chances to speak. The judge also ordered that I pay for her attorney fees, despite all I have done for our son since the court order was signed in I feel the judge is biased, and that I was not given a fair hearing, or opportunity to present exhibits of my own. I also tried to explain to the judge that some parental apps the mother wants put on our son's devices, I was not able to get put on, but I did try. One of the apps completely crashed my son's phone. The other app, I couldn't get it to pair with my laptop. There was also no timeframe in the court paperwork on when I had to have the apps installed, yet the judge is still ordering me to pay her attorney fees.
