**ORDER**

April 20, 2023

The Complainant alleged a superior court commissioner acted disrespectfully and made improper legal rulings in a guardianship case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Denise K. Aguilar and Michael J. Brown did not participate in the consideration of this matter.

I've maintained a room in my home at all times for him. Commissioner dismissed it all.

Saying I was horrible unfit and a total disgrace in every way possible.

She made a statement in reference to there were some wrong doing from me with my uncle money which I was the payee for, she used the words criminal activity without having facts in front of her.

She didn't have enough information to make a statement to me for her to berate me belittle me and condemn me in an open court felt inappropriate on many levels.
