#### **ORDER**

April 20, 2023

The Complainant alleged a superior court commissioner improperly approved a warrant in a criminal investigation.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Denise K. Aguilar and Michael J. Brown did not participate in the consideration of this matter.

The affidavit has the time of the incident listed as at in the officer told the Judge the incident occurred at.
There is also a blood collection report which states the blood was collected at and, supposedly the Commissioner signed the warrant at. Now at the top of the new document which is a sworn statement it says that Officer had the blood withdrawn from my son on at at, and that Officer seized two tubes of blood from the Defendant at that time. There is something wrong with this whole process and the obvious errors and misrepresentations in this warrant before and after it was issued.
