The Complainant alleged poor demeanor, improper procedures, and incorrect legal rulings by a justice of the peace hearing a petition for injunction against harassment.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

No further action is warranted in this matter as the judge in this matter has passed away. The matter is now closed pursuant to Commission Rule 23(a).

Commission member Colleen E. Concannon did not participate in the consideration of this matter.

To Whom It May Concern,

"I want to someone to see them die, I want to live in the hood to hear at night....." says an year old boy. Do I have anyone's attention yet? May I speak now??? We tried to speak of this in Judge courtroom and was treated with complete and utter disrespect and was not allowed to speak.

Myself and my wife have been good, upstanding citizens our whole life. We are parents and grandparents. We don't have a criminal background nor do we don't do drugs. I am retired after working over years and also served in the to help protect my constitutional rights. has a very good job with the County. We are good people who want to be treated with respect, just as we give respect to others.

We have been involved in a dispute with our neighbors and off and on for about years now. This meeting with the Judge was because the were asking for an Injunction against harassment against us (as we have one against them). From the very moment that Judge walked into the courtroom, he was against me!!! The first thing out of his mouth was "why can't you just leave your neighbors alone?" I tried to explain and was immediately hushed. He was so intent on verbally spanking me that he **FORGOT TO SWEAR ANY OF US IN**, therefore this never legally existed, right? What Judge does this?! We are supposed to be sworn in to abide by the constitution and NOT to lie under oath. Judge accused me of being a liar on multiple occasions, here are two examples: 1) He told me I was a liar because I didn't know where the bus stop was. The had accused me of harassing their kids when getting off the bus after school. I have never done this, nor do I know where their bus stop is because I don't have kids, so how would I know!!! There is no marked bus stop in our neighborhood that I have ever seen. The Judge smirked and shook his head in disbelief. Really? What is wrong with this man!!! 2) I was walking to the post office one afternoon when I saw the -year-old child coming down the road. I was on the opposite side of the road, I didn't look at him, I just continued on my way. The told Judge I was walking down the road holding my puppy trying to harass the child. My puppy is a newborn, why would I take it to the post office? Because I didn't!!!! It's another lie.

But Judge told me I was a liar when I tried to defend myself. DO NOT call me a liar because I am NOT a liar!!! If I did it, I will admit it. Judge treated me so rude the entire time!! Not only was he verbally rude to me, the look on his face and his hand gestures were equally as rude!! I told that I was just trying to protect my innocence but got shut down both times. Therefore, I do not go on my daily walks that help my severe anxiety that I am being treated for. Another constitutional right taken away because of "hearsay" from an -year-old child who is VERY troubled.

 even scolded me for moving my papers around quietly and made threats to send me to jail several times!!! My wife wasn't allowed to speak either. Judge completely believed the lies and we were not allowed to defend ourselves whatsoever. Welcome to House. We have never been treated with such utter disrespect in our whole lives and could do nothing about it. I deserve as much respect from the Judge as I give him and will not have anyone talk down to us like he is better than us. Who does he think he is??? Even Death Row inmates are allowed to talk!!

This injunction that was granted to the is based on lies with zero proof again. We met with Judge on to get an injunction against the and told Judge what was going on with the . He listened to us like we were humans and even let us talk. I told him of some of the things that were happening at the and yes, !! was arrested in for and (noise) against us and has started his antics again except at a higher level. He added his children and a to his collection of lies. With this injunction, it has taken away our constitutional rights to bear arms, freedom of speech and the right to a fair trial. My wife has not been involved in this dispute, nor has she said one word to them (even though they call her names from across the street) and her rights were taken away as well because Judge believed people who do their children and contribute nothing to society. They don't work, they live off of welfare and OUR tax money and a grade education!

When the Judge finished with us, we had to wait for our paperwork to be completed. Once again, I had to make a second trip back to Mayer because the Judge did not fill out the paperwork correctly. This is twice now that he has done that!! Perhaps the Judge needs to retire or get his meds changed. I've been to see him three times, but I saw a "different" person each time ranging from fair to UNCONSTITUTIONAL!!!!

In closing, I didn't think this sort of conduct was what our courtroom was all about and it's inexcusable! We have the right to Appeal but how do you Appeal something that never

happened? Besides, the process is so difficult to understand, how can anyone do it without an attorney? I guess that is the point, right?

Judge ... The REAL truth will come out very soon! I have ordered a copy of the audio from this blood bath and will be getting the word out about you turning your head to that I have been reporting for the last years, so you could scold me about more lies! I hope he can live with himself knowing he helped ruin the lives of innocent people. We have to live with this, so I hope he does too.

We will be waiting for a timely response and what you can do about our rights that were unjustly taken away. If not, we will go further.
