**ORDER**

October 20, 2022

The Complainant alleged a municipal court judge was biased against him and made incorrect rulings in a misdemeanor case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Colleen E. Concannon and J. Tyrrell Taber did not participate in the consideration of this matter.

I am writing today with the information required to request a complaint proceeding be initiated against judge

Background: the original case is from it is a case. I have been in appeal for and the same judge was also my judge.( ) this is immediate conflict of interest and him protecting his own decision. I am now without appeal options or ways to combat the charges.

During my initial trial for the charges, which occurred in , I had some major legal issues with my public defender. So much so that I filed an complaint about his criminal and lawless activities and he was later found . This was a huge factor to my appeal. One, which the judge completely dismissed as irrelevant and unfactual even with a letter from the state . Not only was my case of self defense irrelevant but so was the activities of my lawyer which absolutely effected the outcome of my trial and this conviction. I should have easily been allowed a new trial or a reversal of the conviction.

However, I now believe was complicit in my illegal conviction. My constitutional rights for a proper trial without biased and proper legal defense were completely violated, my right to self defense non existent, Appeal was completely tainted by the same conflicted and prejudiced judge.

I have currently up until the writing of this letter complied with this court. I have paid the fine, I

also provided all domestic violence paperwork I can possibly provide to the judge which shows compliance with the counseling portion. This is still not enough for judge . I feel as though he is now acting in complete retribution and retaliation trying to entangle me into more trouble, or time in the courts.

Not only was his legal behavior and decision making illegal and conflicted, he is currently passively harassing me with the courts and jail time/warrant.

I would like to bring this to your agency's attention and have a proper investigation and legal review done of this judges decision making and treatment of my case. I think this is a misjustice and could have prevented, and I also believe it should be corrected. I believe this judge acted in his own best interests and not the legal interests, or what should be determined as the proper outcome of the case. This judge should be held accountable for a violation of my constitutional rights and allowing this miscarriage of justice to continue, and on top of that harass and retaliate thru the courts even with my complete compliance.
