ORDER

The Complainant alleged a justice of the peace made incorrect rulings in a civil case and lost court records related to the case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

- special computer programs
- to be installed by a technician on a nonstandard system
- so a qualified transcriptionist could produce a transcript after special system training

Court was unable and/or unwilling to identify technicians/transcriptionists to produce transcript even after multiple requests by Defendant

Court omitted copy of /or original of exhibits Receipt which was ripped from defendant's hand when he started to note the missing exhibits. The Receipt thus produced is fraudulent in that it misrepresents missing exhibits as having been returned to defendant. Missing exhibits returned by,
