## ORDER

Complainant alleged improper demeanor by a superior court judge hearing a juvenile case.

The Commission determined the judge made a mocking gesture with his hand during an attorney's telephonic appearance for a hearing. The judge mimicked a talking puppet by opening and closing his hand while the attorney addressed the court. The litigant, who was the attorney's client, was present in the courtroom and witnessed the disrespectful treatment of the attorney. The judge also engaged in improper commentary while on the bench. The commentary included monologues about brain function, non-verbal communication, ducks, mercy, and a "yes or no" coin.

The judge's hand gesture while a litigant's lawyer was addressing the court was dismissive and disrespectful. The judge's frequent, off-topic commentaries did not further any court business and unnecessarily prolonged the proceeding. These commentaries were likely deeply irritating to the participants present at the hearing and demeaned the entire proceeding. The judge's conduct was undignified and eroded "public confidence in the independence, integrity, and impartiality" of the court in violation of Rules 1.2 and 2.8(B).

Accordingly, Cochise County Superior Court Judge John F. Kelliher, Jr., is hereby publicly reprimanded for the conduct described above and pursuant to Commission Rule 17(a). The record in this case, consisting of the complaint, the judicial officer's response, and this order shall be made public as required by Commission Rule 9(a).

Commission members Roger D. Barton and Joseph C. Kreamer did not participate in the consideration of this matter.

I wish to acknowledge that I did gesture with my right hand, bent at the wrist and opening and closing my hand while one of the attorneys was addressing the Court. I was wrong. I regret having done that. I regretted doing it after I did it and I will never do such a thing in Court ever again. I can explain

why I did that, but it would not change the fact that it was wrong to do. I deny rocking my chair from side to side. My chair does not rock. I am human and I make mistakes.

As to the other matters set forth in Mrs. Tackett's complaint, I am left with the impression, after listening to the audio recording, that Mrs. Tackett's perception of how she was treated by me and how I behaved are quite different than mine. I am ever so grateful that an audio recording is available as it lends more substance to mere words on paper. The specifics of Mrs. Tackett's allegation are not reflected in the recording. I never said her son was guilty. In fact, I did say I had an open mind and would continue to have same until all the available information was out and in everyone's possession. I was not disrespectful to anyone in that hearing. The audio recording reflects quite the contrary. I did not "attack" anyone. I did address them when they were non-verbally disagreeing with what was being said to the entire Court, but it was not an attack, and it was not disrespectful.

The paternal side of the family, to which I addressed them to make certain who they were, were trying to non-verbally communicate with me [as I was the only one who could see their non-verbal communication]. I responded civilly and courteously. The recording bears this out. My reference to " $1+1+1$ equals three" and "if it walks like a duck..." were my attempts to explain how the facts known at that time pointed to father being responsible for the. You will hear in the recording that the lawyer for the baby and the Assistant Attorney General, as well as mother's counsel I believe, all drew the same inference.

The recording also has me asserting that all the facts ("pieces of the puzzle" as father's attorney argues) are not before the Court and that I was keeping an open mind until they were before the Court.
