**ORDER**

September 8, 2023

The complainant alleged biased and improper legal rulings by a justice of the peace hearing traffic cases.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Roger D. Barton and Joseph C. Kreamer did not participate in the consideration of this matter.

**To Whom This May Concern:**

This is the first of many complaints to be sent off relating to this judge.

On this particular case, I asked the court to dismiss the case because they had been delaying ruling on matters beyond \_\_\_\_\_ days. This judge \_\_\_\_\_ completely ignored my motion and went forward to find me guilty beyond a reason of doubt despite the fact that this case was not settle in due dilligence. The case was sent back to the \_\_\_\_\_ court and on \_\_\_\_\_ which is a Sundav- I received an email from the courts demanding that I sign a payment arrangement and return within \_\_\_\_\_ days as it states in the email. On the pdf file that was attached to the email it states and is highlighted for me to sign the payment plan and return within BUSINESS DAYS. I wrote a letter to the court about my financial hardship and about how I have no income due to being to sole caregiver of my parents right now as well as taking care of my \_\_\_\_\_ children as well.

The email is signed by a court clerk named \_\_\_\_\_ but to my personal knowledge, \_\_\_\_\_ has not worked at the courthouse in quite a while. In my other complaints that I will submit along with this one, she often threatens me with trying to throw me in jail simply because I am unable to work and have no resources to satisfy her demands. The court system is not suppose to inflict financial burden upon poverty stricken households. All of the times I get stopped it is racial profiling and the officers make sure to cite the tickets as criminal speeding. The acts done by this judge and her court are not transparent at all. Both judge and staff do not conduct themselves with high standards of upholding the integrity of the judiciary and have failed to avoid conflicts of interest and the appearance of impropriety. I have an old printout of my public record that shows that this case was connected to \_\_\_\_\_ past cases that were closed and it doe not show up on current record but goes to show that she is bias towards me and is simply trying to put hurt on my record to prevent me from being able to obtain a job or any opportunity.
