**ORDER**

February 22, 2023

The Complainant alleged a superior court commissioner made improper rulings and violated his rights in a mental health case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

In these \_\_\_\_\_ illegitimate \_\_\_\_\_ County Court cases, \_\_\_\_\_ and \_\_\_\_\_, my civil rights were completely violated, I was framed twice, my name and reputation were slandered, and my character was defamed. However, this complaint and report will also reflect the fact that these \_\_\_\_\_ County Court cases, \_\_\_\_\_ and \_\_\_\_\_, are illegitimate and false interpretations of the truth. In both illegitimate \_\_\_\_\_ County Court cases, I was not given any opportunity at all to defend myself against the allegations and mischaracterizations made against me, and my civil rights were completely violated throughout the duration of these \_\_\_\_\_ cases. \_\_\_\_\_ orders forced me into a position where I had no freedom for over \_\_\_\_\_ days at \_\_\_\_\_. When I attempted to obtain information as to why I was at \_\_\_\_\_, the staff provided no explanations as to why I was there and it was difficult to even inquire of any of the staff and physicians at \_\_\_\_\_ as to why I was there and when I would be released. I filed multiple grievances against \_\_\_\_\_ and the \_\_\_\_\_ detailing the cruel, unhealthy, and unusual conditions for which I was being held under while I was there.

Over the time period of \_\_\_\_\_, I was falsely portrayed and completely misrepresented as someone I was not. Commissioner \_\_\_\_\_ judicial misconduct and actions through ordering these emergency hospitalization orders resulted in my name and reputation being slandered and I was completely mischaracterized leading to defamation of my character.

In overview of Commissioner \_\_\_\_\_ judicial misconduct, I am reporting that he approved illegitimate involuntary evaluation orders without reviewing any medical documentation at all about me. Furthermore, Commissioner \_\_\_\_\_ did not consult with any medical professionals nor physicians in the process of ordering me to be involuntarily held at \_\_\_\_\_. Commissioner \_\_\_\_\_ ordered an involuntary evaluation \_\_\_\_\_-day hold, which basically consisted of me being locked inside a community \_\_\_\_\_ with mentally \_\_\_\_\_ people mentally \_\_\_\_\_ people, and homeless people without any reasonable cause for me being there in the first place. So I basically stayed in a safe position of the \_\_\_\_\_ away from everyone and kept to myself until I could speak with the \_\_\_\_\_. I demonstrated to the \_\_\_\_\_ and staff \_\_\_\_\_ that I was not a danger to self nor others, that I was mentally stable, and that there was no reasonable cause for me being held at the clinic and certainly no reason for me to be hospitalized in any way. The \_\_\_\_\_ physicians found at both instances that I was not a danger to self nor others nor was I persistently nor acutely disabled, and that there was no reasonable cause for the involuntary evaluations, and that I was permitted to freely leave at the end of the \_\_\_\_\_-day hold.
