**ORDER**

September 14, 2022

The Complainant alleged a justice of the peace heard a case in which there was a conflict interest and abused the authority of the judicial office to influence a criminal investigation.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Denise K. Aguilar, Roger D. Barton, Colleen E. Concannon, and Delia R. Neal did not participate in the consideration of this matter.

I am respectfully requesting an investigation by the Judicial Conduct Board into Judge \_\_\_\_\_ for unethical behavior and misconduct.
