The Complainant alleged a justice of the peace did not follow proper procedure when considering an injunction against harassment

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Louis Frank Dominguez did not participate in the consideration of this matter.

In this case, the Defendant asked to have the hearing rescheduled. But this in itself would not change the rules about having evidence and witness's. The court instructs victims to bring their evidence and witness's with them to the hearing. No discovery to the other side necessary. Once this case's hearing was reset, I and Defendant appeared in front of

I stated I had a witness to appear that had only days prior made himself known and that he was willing to testify. The Judge denied that my witness could appear. It was obvious the Judge was operating on regular civil trial rules and not the Harassment Injunction hearing rules. And he applied them erroniously. This caused confusion in my mind as it conflicted with what the court supervisor told me. I didn't know what to say, and so when the Judge said are you ready to proceed, I said no, thinking he would reschedule the hearing so my witness could appear. Instead, he dismissed the case improperly. Doing so has now let the Defendants attorney file for in attorney fees against me, the victim, and when I had photographs of Defendant in the act of his crimes, and eye witness to my car being shot up. was completely destroyed By by not doing his job properly. Had he let me properly present my witness and evidence, the Injunction would of stood. It's not like a little evidence, or sketchy evidence. It's caught in the act photos, proof beyond a doubt.
