in conjunction with others has resulted in my wife and children being evicted from our home				
and the stealing/taking of wealth from an family in the loss of				
my real property; and yet to this date I have not received anv compensation for.				
Under Judge authorization, attorney directed the

to not sent or send any documents to me and to send them all to him .				
and to send any funds to him J thereby taking				
the money that was supposedly paid for the real property for himself (attorney fees at higher				
rate) and others who assisted him in the venture. This cause an undue tax liability placed				
on me from the sale of the real property which occurred under my name, yet I never received				
any monies for the sale of the real property. So Judge authorized a third party,				
that filed a false claim against me and without my approval, to transfer ownership and sell				
my real property, and sign my name on legal documents, that resulting in the house and money				
being taken and all kinds of violations happening, Judge actions violated				
Arizona Code of Judicial Conduct.
