**ORDER**

April 20, 2023

The Complainant alleged improper legal rulings by a superior court commissioner hearing an order of protection.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Denise K. Aguilar and Michael J. Brown did not participate in the consideration of this matter.

for my car and was arrested. I was on  
Probation at the time. The Sheriff that

Called my Probation officer. Because I was  
being arrested for failing to comply with  
a Court order my probation officer filed a

the only reason my probation officer filed a Petition to revoke on was because I was being arrested for failing to comply with the Court order. (Order of Protection) from until

I was incarcerated in the jail. I bonded out

Once released I requested a hearing in the Court that granted Order of Protection. Comm. granted a hearing. During that hearing I brought up the issue of not living in our home when she applied for the Order of Protection. (The hearing was held

# ) Judge asked

if this was true and admitted to it. Judge told that she could be sued for damages because I had to sleep on the streets, loss of wages... ect. Also during that hearing I brought up the issue of living in our home.

removed and her children from our home because they felt needed to be supervised around her children, this is why was not staying in our home when she applied for the Order of protection. Needed to find a place that would approve and an adult to supervise while she was around her children. approved home. (the children's grandmother).

told the only way she can stay with is if moves for some reason is not allowed to be around children.

During the hearing on I bring up the issue of living in our home and says "

" So at this point. I have been arrested kept in County jail, kick out on the streets, with an Order of protection keeping me from going to my home. But is living in my home because he can't be around children in his home, and is in

home because that was the approved address  
and ... was the Approved adult by ...  
I don't know why ... wasn't allowed  
to be around children. He is their uncle.  
However the address (my home) is about  
from school, so if  
isn't allowed to be around children  
why move him into a school zone?

Because of the Arrest on  
(failing to Comply with the Order of  
protection) my Probation was revoked. On  
I was sentenced to 1.5 years  
in prison. I still have a pending case in the  
court for failing to Comply  
with the Court order.

I wrote several times to Comm.  
and told her that I'm in prison because  
put our address on the order of protection.

The Same Order of Protection Comm  
told She shouldn't have put the address  
on and because she did she could be sued.

my question is.. If knowing  
falsified documents and the judge knows  
(Comm) why was I sent to prison?

Recently I had a conversation with . . . I asked why she put our address on the Order of protection when she didn't live there. . . . claims that I put her up to it. from the facts from the hearing on . . . in front of Comm . . . it may be possible that put her up to it. . . . claims that told her to do it that way her children wouldn't be split up and her and . . . could swap homes without me interfering.

I keep submitting letters to Comm and motions requesting a new hearing. I would like the conversation between and : on record. And I've asked several times how can i be sent to prison for something I did. I was the victim in this whole mess.

The entire Order of protection that filed was a lie. She claimed I had a fire arm.

called the police on me at least 15 time in a two month period. not once did she call about me having a fire arm. She also called my probation officer numerous times but never said I had a fire arm. She claimed I kicked my dog over and over. I care more about animals
