**ORDER**

April 20, 2023

The Complainant alleged irregular procedures and biased decisions by a superior court commissioner hearing a family court case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Additionally, the complainant requested to present his case orally before three commissioners, which was interpreted as a request to appear before the full Commission. The Commission found no good cause to support this request, and the request to appear is hereby denied.

Commission members Denise K. Aguilar and Michael J. Brown did not participate in the consideration of this matter.
