ORDER

The Complainant alleged improper rulings by a justice of the peace hearing a petition for a protective order.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Colleen E. Concannon and Scott C. Silva did not participate in the consideration of this matter.

She even confused my witnesses, & when I tried to clarify, she would get upset with me, so I would ultimately drop it. I felt unheard in this entire session & feel that she has let a very dangerous person manipulate the courts to allow him to hurt people further. I & others fear that the Plantiff may even have connections that swayed the court & or Regardless of reasons, however, she ultimately did not make me think that justice was properly served, nor did she make me feel welcome or heard to present my case against: She made accusations of me without grounds as well during the case. She has been the first person along this journey who has sided with & she told me that it would seem I am a bad influence on his whom I have only tried to protect & nas zero grounds to make such an accusation. asked me why I felt I had any right to do what I did , & I felt that was a rude way to accuse me of wrong doing
