**ORDER**

February 16, 2023

The Complainant alleged corruption and bias on the part of a justice of the peace.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Please note that the eleven members of the Commission, not Commission staff, review all complaints and make a determination as to whether there has been a violation of the Code of Judicial Conduct, and if so, what the appropriate sanction is. Your prior complaints were reviewed by the Commission members, and they determined there was not clear and convincing evidence of a Code violation and dismissed your prior complaints. You may disagree with those decisions, but that is not a reason to be verbally abusive to staff.

The Commission is in receipt of the 4 emails you sent on in which you attached several photos of the first page of our complaint form. The complaints name Judge \_\_\_\_\_ Judge \_\_\_\_\_ Judge \_\_\_\_\_ and Judge \_\_\_\_\_. These complaints name a specific judge and could be processed, however, you do not make specific allegations about their conduct. You make vague statements that they have prejudiced themselves and that some have a conflict. You fail to specify how these judges have prejudiced themselves or what conflict they may have which would constitute a violation of the Code of Judicial Conduct. If you describe the specific conduct of these judges that you believe constitutes ethical misconduct, then we can process your complaints. However, we will not be processing these complaints until you provide more specific allegations.

You also submitted a complaint form in which you name "All Court Adimt." We are unable to process this complaint. We can only process complaints against specific named judges. The Commission has no jurisdiction over court administration or court employees – only judges.
