ORDER

The Complainant alleged bias against women and improper rulings by a superior court judge hearing a family case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Colleen E. Concannon did not participate in the consideration of this matter.

I am hoping that this letter finds you well. I am unsure if you saw back in _____ a child named _____ was killed by his father _____ in which the mother warned and expressed her worries of the father being abusive and the child being in danger with the father, in which _____ and other judges but as _____ did as he always does and says Spousal and child abuse is fake news and gave the father unsupervised parenting time in which the father murdered the child and himself shortly after. After that incident Judge _____ continued his ignorance and misconduct to live and death situations for children with abusive fathers. I cannot speak for all women or mothers on Judge _____ case load but the few who have spoken out or mentioned the injustice is shocking, the belief that some people did wrong things in their cases and received consequences is very understandable but the biased actions and decisions from a elected official who swore to protect the public but most importantly protect children is a slap to the face to the community. We the people/community of _____ County are asking that the higher position people who oversee _____ give him the consequences and give him a reality check that he cannot use his mental health and trauma to punish mothers and children for what happened to his in his childhood. _____ has blackmailed mothers to settle or do what is beneficial to the father. I will give you a few examples of a case I am very close to if I am not mistake this happened _____ of _____ this case had a relocation filing waiting to be heard in front of this court, Mother was hesitant and scared for the father to have unsupervised visitation the reasons for mother being hesitant was father drove _____ minutes on the freeway to drop child off to mother and the child was wrapped in a thick blanket at the time the child was around _____ months old and was not safely put in a seatbelt in the car seat to be secured in the car. Other reasons were father was very physically abusive to mother when she was pregnant, Father was also deported in _____ and came back illegally and is in the united states illegally and could be deported anytime. The father had also many times that he did not want to be a part of the child's life many times because he did not want a child and another reason was because mother did not give him attention and did not want to be with father. The father's family also threatened mother with kidnapping the child and taking him to _____. The father was out of the child's life for _____ months which under Arizona laws A.R.S Section 8-531(1) . At that time father was having _____ hour supervised visitation and child had injuries after the visit and father refused to speak to anyone about what happened and started threatening mother, All concerns were brought to the judge and judge _____ refused to hear mother's side and

important views in the situation and judge : refused to hear mother out he only said " You either agree to the visitation being asked by father or I/court will not consider you wanting to relocate." Under duress the mother accepted in fear that judge would not consider the relocation and in fear that the judge would give unreasonable and unsafe parenting time to father. Judge was also very rude and disrespectful and called mother's father/family toxic for wanting to keep mother and child safe, it was very uncalled for and goes against judicial ethics (judges do not have a right to use rude, de-meaning and condescending speech towards litigants). Canon 3(A) 3 Impatience & discourtesy to litigants. Which has resulted in sending child with multiple bruises, cuts, busted lips and head injuries, when father was asked what caused injuries the father would get defensive and threaten mother. In which mother has documented everything through and who than contacted . This has been a year old ongoing case in which doctors have pleaded with judge on how dangerous it is physically and mentally for year old . The child's pediatrician has mentioned the story that father has told us does not align with type of injuries that have been caused. Judge has refused to acknowledge any recommendations and paperwork for what doctor's state. Father in this has confessed and admitted to judge that he strangled mother on and that he has been physically discipling the child in a gruesome way such as "smacking, hitting child's hands as punishment. Father was diagnosed with multiple mental health issues through perception counseling that can be dangerous for a child to be unprotected with someone who has those illnesses where judge sealed those records so I am unsure if I can mention those specific illnesses here. But judge refused to order father to get any type of mental health help and judge . refused to do anything on the proof that father was abusing mother and was also abusing the child, Judge believes any information even false information given to him by the father even made up stories, Judge refuses to ask for proof and merely believes lies even though mother shows proof saying otherwise and proving father is lying under oath, father has been proved lying under oath multiple times. Father has been in contempt of court orders multiple times motions were filed and has refused to hold the father in contempt for his unlawful actions. The father has broken court orders, orders of protection and has refused to hold the father accountable that is one of the many ways judge shows impropriety and favoritism and judicial misconduct. only way to fix things is to threaten & blackmail mothers to do as father wants, Judge rulings are not only unlawful shows impropriety Judge allows father to defame mother's and people not so forwardly linked to the case, judge says many things that are out of line, disrespectful and makes a situation times worse and hostile. Judge lets fathers/other party run his courtroom and make a mockery and joke out of his courtroom. The fathers are allowed to defame the others person, career, is allowed to not follow court orders. Judge does not hold fair trials or gives parties the same time to make their arguments, especially for mothers and that is a constitutional right everyone is allowed to have. Mothers who speak out of the bias and misogynistic ways and misconduct from judge publicly or speaks about it to other judges , will than retaliate in a way that is unsafe for the mothers and children. Judge refuses to ask for evidence or proof of allegations a father makes, for example the fathers in these cases can say he is God and the owner of Arizona and will simply not bat an eye and believe the father.
