ORDER

The complainant alleged improper rulings by a superior court commissioner hearing a petition for order of protection.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

The Judge, _____ granted an order of protection with no evidence. When provided evidence, contesting the order, she did not take it into consideration. The judge, did not even consider that the plaintiff lied about her employment for her entire time here in the _____ . She also accepted text message evidence that only included the defendant's text messages, and not her text messages. The plaintiff clearly stole the defendant's only reliable vehicle with his veteran plates, and disability sticker, and the judge did not consider this. The judge was aware that these actions were putting a _____ disabled veteran in the position of homelessness, and did not care. The defendant was the only one who pays all financial responsibilities and has all of his property in the house that was given to the defendant who has never paid one bill her entire time in the _____ since _____ which evidence was provided, but not considered. The defendant has a _____ service dog, that was wrongly rehomed without his permission on _____ by the plaintiff who was responsible for him while the defendant wasn't in his home due to the order of protection. The defendant was willing to provide evidence that showed he was mentally abused by the plaintiff for the past _____ years, but the judge did not want to take it into consideration. This judge is taking away the only stable parent in a child's life who is diagnosed with _____ , and putting another homeless veteran on the streets wrongfully. This entire case was wrongful use of the court system, and was supported by the judge's decisions today. I understand that nothing can be done now, but this judge needs to be stopped before she wrongfully ruins more people's life.
