**ORDER**

October 6, 2023

The Complainant alleged poor demeanor and improper legal rulings by a justice of the peace pro tem hearing a small claims case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Barbara Brown, Colleen E. Concannon, and Louis Frank Dominguez did not participate in the consideration of this matter.

The following is the biased treatment I received by the court. civil

I filed the above civil case as a continuation from a small claims case where I was cheated out of a judgment by either the incompetent gentleman " " as judges or by the Supervisor.

The defendant filed no response nor did they respond to the subpoena served upon them as well.

I then went to the court in person to commence default proceedings and this Supervisor named " " came to the window once she was summoned by the clerk at the window. As she pretended to be going over my paperwork she engaged me in conversation, eliciting personal information in the process.

I told her my truck had been stolen so I had to walk from the lite rail station several blocks away.
