**ORDER**

November 27, 2023

The Complainant alleged a municipal court judge did not accommodate his disability in an order of protection proceeding.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

In this case, supposedly recorded in court, a certified letter was sent from this court to me, according to my USPS Informed Delivery Application, which I never received, the certified # is  
An active investigation is ongoing by the postal service. This is important because not receiving the letter before the hearing allowed no time to prepare, no instruction, and most of all no assertion of why I was to appear. If not for an extremely vague text message from the court, and my inquisition to understand, I would have not been present at the sham hearing that occurred.

I was given no opportunity to explain my disabilities to the court, which I was assured I would be allowed to do by the administrative assistants. This is important because being diagnosed and treated for being disabled is a vulnerability unavoidable in my circumstance. The plaintiff perjured herself with no retribution, the judge clearly sided with the female plaintiff and encouraged conviction. I am outraged and severely injured by the actions of this judge. During this hearing, I was humiliated, embarrassed, belittled, and wrongly indicted of inappropriate behavior because the judge would not hear all the facts. When I stated it is going to take some time to explain I was shut down and ordered to move on, incompetence at its finest from this judge. After grasping at all the straws possible, the plaintiff convinced this judge to accept small portions of a very long text message to condemn me as a less than God fearing man. The judge has no idea of how the message started only that she stumbled on something she might be able to use to hurt another man not a woman but a man. Being disabled, I was not able to defend myself against a prejudice judge who appeared to detest handicapped people, United States and obviously hates the male species of human beings. Her rude inappropriate behavior is deplorable and not what a tax paying citizen should expect in a court of fairness. The plaintiff submitted portions of a discussion which favored her position however, after asserting to the Judge that only portions of the evidence was submitted it was clear to me the judge had all she needed to shame me into believing she can do anything including punishing another man because it makes her feel good with her power. Judge used her bias and prejudice as a female to discriminate against me, she made outrageous accusations of what was in my mind, without any merit or reason for hating me so fiercely, she ignored the fact of my disabilities and does not deserve to be a judge. For example, this judge had the gall to tell me what I was thinking without any evidence or input from me, I think I still own my thoughts. At least on two occasions I asked the court receptionists to allow me to explain my disabilities to this Judge, they assured me I would have time to speak to the judge to tell her that I am taking for my condition, this never happened. I have not received any paperwork from this Court, the only way I found out was a text message. Unfair Judge! This judge is unfair. I am extremely disappointed in the Arizona Justice system and this judge needs ethics, bias and handicap training.

My appeal in this case is forthcoming because the city pay this court's employees to stand around minutes before closing time and not accept any appeals until the following business day. I am requesting assistance from the American Disability Association for the injuries sustained today.
