The complainant alleged a city court judge did not listen to a litigant's concerns and failed to consider a disability when hearing a criminal case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Denise K. Aguilar did not participate in the consideration of this matter.

In my recent telephonic hearing he states that he can only investigate my DUI case an that I should contact police about that matter. Even as I've already written a letter months before hand explaining in detail what's occurring and the police report associated to mv stalker. He never asked me an questions in regards to my stalking letter about jail officer and her husband and doesn't want to others that have been stalking me. I am in fear for my life now and feel like judge assist me for reporting him initially as a form of retaliation.
