**ORDER**

May 12, 2023

The Complainant alleged a superior court judge exhibited poor demeanor and racial bias during a civil hearing. Complainant further alleged the judge was under the influence of pain medication at the time of the hearing.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Roger D. Barton and Christopher P. Staring did not participate in the consideration of this matter.

JUDGE COMPLAINT\*\*\*\*

Dear Arizona Commission on Judicial Conduct,

I am writing to file a formal complaint against Judge \_\_\_\_\_ and Commissioner \_\_\_\_\_ as well as their judicial staff, for their biased and prejudiced conduct during my recent court case. I strongly believe that their actions have undermined the integrity of the Arizona Civil Justice System and resulted in a grave miscarriage of justice.

From the outset of my case, it was evident that Judge \_\_\_\_\_ was unprepared and ill-equipped to conduct proceedings fairly and impartially. During the hearing on \_\_\_\_\_ Judge \_\_\_\_\_ was on a video conference and appeared to be incoherent and disoriented. This caused significant confusion and frustration on my part and further undermined my confidence in the judicial system.

In summary, Judge \_\_\_\_\_ conduct has been unacceptable and unbecoming of a judge. I urge the Arizona Commission on Judicial Conduct to investigate this matter thoroughly and take appropriate action to ensure that justice is served in my case and in all future cases before these judges. I am writing to file a complaint against Judge \_\_\_\_\_ and Commissioner \_\_\_\_\_ as well as their judicial staff, for their biased and prejudiced conduct during my recent court case. Specifically, I am appealing the decision made by the lower court in the hearing on enforcement of the order for return of my vehicle, which was denied by the court despite clear evidence in my favor.

\_\_\_\_\_ of the \_\_\_\_\_ provided me with body camera footage that shows the defendant, \_\_\_\_\_ admitting to repairing and blending my bumper. Despite this evidence, Judge \_\_\_\_\_ has still sided with the defendants.

Throughout the proceedings, Judge \_\_\_\_\_ did not follow the rules of Arizona civil procedure and showed partiality towards the defendants, \_\_\_\_\_ and I \_\_\_\_\_ to the detriment of my case. Furthermore, he allowed the defendants a \_\_\_\_\_ of default, during which time his staff purposefully placed an unknown address on the handed off case to the commissioner who handles default cases, in order to give her a biased reasoning on why the defendants did not respond. Only after I \_\_\_\_\_ caught this and filed a motion, did they correct this error, which had already set a prejudice approach from the commissioner and her staff, who were extremely rude and even threatened to call the police/security on me for asking them questions about my case.

I believe that Judge \_\_\_\_\_ has shown extreme racial discrimination against me and is upset that the defendants, whom he favored, had to give me back my vehicle. The defendants have caught wind of the bias that Judge \_\_\_\_\_ has had against me, and they have been emboldened to not fully comply with the order that he issued on \_\_\_\_\_ which ordered them to release my vehicle and all of my parts.

In light of these circumstances, I am requesting that the Arizona Commission on Judicial Conduct investigate Judge \_\_\_\_\_ and Commissioner \_\_\_\_\_, as well as their judicial staff, for their biased and prejudiced conduct during my case. I also request that this Commission take appropriate action to ensure that justice is served in my case and in all future cases before these judges.
