**ORDER**

September 15, 2023

The complainant alleged a justice of the peace did not properly credit money paid towards a fine imposed in a criminal case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Barbara Brown and Delia R. Neal did not participate in the consideration of this matter.

The states prosecuting attorney opened the law book to show me the amount of the fine i will be ordered to pay after entering a plea of guilt to A.R.S.13-1502

The two remaining charges that i did not plead guilty to were dismissed by the states prosecuting attorney A.R.S. 13-2904 and A.R.S. 13-1603

Judge read the terms of the agreement and then commented "

judge approved the plea agreement and ordered me to pay a fine in monthly installments in the amount of per month until is paid in full

disposition date is and is still active today in the current year

what i discovered when accessing this case is falsified information regarding one of the two charges dismissed by the state falsification that a guilty plea was entred by me to a charge that i did not plead guilty to A.R.S 13-2904

the dates that show when an activity occurred are correct dates that an activity did accure but the activity is falsified misleading one to believe that a review had taken place for that date when in fact the true activity for that date was that i made a payment towards the fine i was ordered to pay the dates that are falsified are consistant with the dates that i made a payment

the dates that show a fta and a warrant was issued are consistant with the dates that a payment was missed resulting in an arrest to happen and an additional added to the balance of the fine i was ordered to pay for all of the payments made by me in the form of cash were collected without showing accountability collected at the office of the court during the time frame of the years

, it shows in the case log work sheet used by the clerk on the balance owed was a note that says l/p on i called to notify i could not make a payment on that day and said i would be in on the following monday to make my payment that following monday a warrant was issued for my arrest on a false fta on the balance owed

The copy of the case log work sheet sent to me by the senior court clerk it appears that the log sheets are missing a series of payments that i made for the dates of the dates appear in the log sheet but does not show a new balance update i specifically remember during a release from iail i requested to the judge to lower my payments and she verbally made a deal she said to me "

i talked to a friend of mine who paid payments in a row on those dates mentioned remember earlier i noted on my balance was in the late months of i made a call to the judge after finding out that a warrant had been issued for a fta i requested that the warrant be quashed on account i did what she asked me to do with the timely payments but she did not hold up her to her promise she stated " the payments exceeded the last known balance i remebered prior to the timely payments the payments were the last payments made by me until an arrest happened forcing me to continue paying per month if a payment was misses a warrant for my arrest was issued under false attestation that i failed to appear

judge became upset after reading the plea and she commented " this comment tells me she is aware that she does not have a legal reason to believe i deserve more punishment if there were a legal reason she would have used the legal language this the comment is the judge expressing her desire to empose a steaper punishment even though judge sentenced me according to what is allowed for the specific plea of guilt to A.R.S. 13-1502

in order to carry out a punishment of ones own creation making it look as though nothing is wrong to carry out this punishment the original punishment cannot be accounted for which is why the original is unnaparent and payments went unaccounted i want judge to show documentation that is signed by the prosecuting attorney and directly related to the terms of the agreement that details the charge with a plea of guilt for A.R.S.13-2904 as it appears in the case she will not be able to provide proof because it does not exist of an order that says i am required to appear once a month for a review for a period of years i want her to prove i owed all of the money that has been collected how is it possible to account for the extra added for every time a warrant was falsly issued under a fta and how can she account for the extra housing cost added to the balance every time i was arrested on a false warrant show justified untampered warrants that can be concidered justified answer with a legal reason for a warrant that shows right now that i failed to appear
