**ORDER**

September 15, 2023

The complainant alleged bias and improper legal rulings by a justice of the peace hearing an injunction against harassment.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Barbara Brown and Michael J. Brown did not participate in the consideration of this matter.

[ ] is friends with my neighbor [ ] " [ ] most recent attack on my person has been to sign into effect an "order of protection" on behalf of his friend [ ] in order to strip me of my legal right to be armed and protect my home, to father cost me money, to destroy my reputation and paint me as an aggressor and in retaliation for my speaking out about his violating my civil rights and trying to have me falsely arrested on at least [ ] occasions. [ ] has been stalking and harassing my family since we bought our property. This included at least a half dozen cameras aimed at my [ ] acres. [ ] even had a camera on the corner of his property aimed directly at my gate. [ ] tells ranchers [ ] and [ ] of [ ] when we leave our property so that they can come beat, lynch, torture, mutilate and kill our animals. This includes savagely beating and stomping to death baby goats, chickens, ducks, stabbing babies inside pregnant goats, slicing their ears off as souvenirs. Furthermore, [ ] facilitated the theft of thousands of dollars in fencing, waterpipe and our 3000-gallon holding tank. His clear view of our property allows his friends to steal our things. [ ] diverted the river and drained [ ] lake. He drives his ATV around to pull his storage cards after each attack or theft. So, we know he is watching, not calling the police in order to facilitate and protect the thefts. [ ] other friends in the [ ] Sheriffs as well as [ ] Department, and his connections with the [ ] Church create violent attacks and trespass since [ ] and continues until today. He did the same to the previous owner of our property. [ ] helped him harass her as well as constable. [ ] as he constantly monitors his cameras, harassing us if we are on the public road in front of his land.

The first attack resulted in brain damage to [ ] of our [ ] dogs, [ ] of which were six-month-old puppies the stomping and beating head of two baby goats and [ ] chickens, ducks and turkeys. The men parked in full view of [ ] cameras on the corner of our property. Since then [ ] has repeatedly surveilled me and my two daughters with binoculars (including cutting trees on his property in order to peep at us with binoculars). And telling sheriffs " [ ] " after, via horseback, [ ] lassoed, repeatedly lynched, tortured, mutilated and dragged a small, pregnant female goat, slicing her ears off. The past ten occasions of trespass of these men, [ ] has facilitated their escape and been harboring them on his land. They simply walk to the back of his property and enter through his gate. We have followed their footprints there. They have also actively evaded us while on his land and even waited in the woods to enter his land via the gate he has installed to block the public road via his ATV. Each time we seek to catch them after trespass, they flee to the back or front of his property and enter his property. [ ] compound lights come on, indicating their arrival.

[ ] sheriffs have refused to go speak to him on each occasion, waiting until the next day for the men to leave.

One of the things [ ] and his gang of cowboy thugs has done is file false animal control reports on our livestock guardian dogs. [ ] , as Constable, was to serve that warrant for that criminal complaint. He used his postion as constable to tresspass, threaten me with assault and try to have me falsely arrested. now he is using his postion as Justice of the Peace to do the same thing. I fear for my safety and I fear that this abusive and Narcisistic man is going to continue to threaten mv freedom and safety. I fear for my life based on the threats I have received from his friends in the [ ] department and the horrific violence they hacve already done to my family, my children and my animals. [ ] is a dangers, violent and abusive man and he is using his position to retailate gainst me and falsely accuse me, as are other members of the [ ] church and those under their instruction.

To serve the false animal control report against me, \_\_\_\_\_ unlawfully undid our gate chain and drove his white truck into our property without a warrant. He drove up our driveway, blocking me with his truck. I got out of my truck as I was driving my daughter to work. \_\_\_\_\_ sat in his truck grinning at me as I told him to get off my land as he did not have a warrant. He loudly responded with a huge grin, "\_\_\_\_\_". I took the papers from his hand and told him that he had no legal right to be on my land, that he was trespassing and needed to get off my property. I started to walk back to my truck. He immediately exited his truck rant at me with his fists clenched leaned into my face and screamed, "\_\_\_\_\_". I thought he was going to swing on me and physically assault me. Then he looked up and saw my daughter in the truck, turned and ran back to his vehicle. He quickly backed through my gate, then blocked me from leaving. He then realized we were filming him and started looking afraid. The entire three miles out he repeatedly swerved his truck to prevent me from passing him on the dirt road, driving really slowly. I saw him make a call and told my daughter he was setting me up for something. \_\_\_\_\_ called his friends at the \_\_\_\_\_ Sheriffs Department and had them drive two trucks to aggressively block me in at the end of my road. Then told me they could "\_\_\_\_\_". They literally put me in their database as "VIOLENT" meaning they can use other cops to execute me or beat me to death or harass me at any time they want. \_\_\_\_\_ told them I was trying to attack him while repeatedly trying to make me rear end him. Those cops told me we "\_\_\_\_\_". They unlawfully detained me for over \_\_\_\_\_ minutes at \_\_\_\_\_ request as he drove off laughing in his rear-view mirror.

When we went to the court date i saw \_\_\_\_\_ there. I told him to his face that he is a liar and a coward. I told the \_\_\_\_\_ attorney what \_\_\_\_\_ did. He went and talked to \_\_\_\_\_ he came back and told me, "\_\_\_\_\_". I told him to do it. I was so angry. My daughter was there and repeated exactly what \_\_\_\_\_ has said and that she was a witness. I staed in the court recorrd that he threatened me out in the hall, which the attorney then denied. He quickly then signed off on the animal control case and told me I "\_\_\_\_\_". I was not yelling at all. I was speaking in a normal voice., Again, these men were trying to paint me as aggressive and violent. I did nto realize at the time \_\_\_\_\_ was trying to be eleccted as Justice of the Peace. Now, in that role, \_\_\_\_\_ has signed a restraining order against me in retaliation for me daring to tell anyone anbout his abusive, threatening behavior, abuse of power, coercion and witness tampering by trying to have me falsely arrested for reporting terrorism, felony anima abuse and many other crimes his friends are engaging in.
