## ORDER

### September 22, 2023

The complainant alleged a municipal court commissioner prejudged his case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission members Denise K. Aguilar, Barbara Brown, and Louis Frank Dominguez did not participate in the consideration of this matter.

It was awkward how friendly their conversation was, and did not seem typical. It was hard because in my mind, I felt that no matter how well I presented my reasons of contesting my ticket, that judge was not going to go against what the state representative's decision was going to be. I even had the thought, after I had left the court to see how many cases have come before the judge and the state witness together, and how many were sided on the state witness.

Because of covid or l was other reasons, the scheduled court date kept being pushed back and back. Come being one of without a job, and was going to start the process of applying for police departments, . and how those. I truly felt that with the construction that was going on at and many other vehicles were in the intersection, and going as slow as I was going, I truly felt like I was not at fault. After the judge made his decision which went along with what the state witness felt like should happen. I wrote a motion to see if the judge would have a soft heart in giving me a second chance to be able to go to traffic school so that I did not have to pay the ticket, and also have to go to traffic survival school. I even asked if I could donate money to someone in need and I was informed that they did not have any program like that.

I paid the fine, and submitted my motion immediately. I really was hoping that judge would find it in his heart to give me a second chance to go to traffic school rather than pay the fine to the courts, go to traffic survival and still have the points on my record. I never heard anything, nor did I receive anything in the mail.

I called the court on because I had not received anything in the mail from the courts in regards to my motion and was asking what I needed to do to make a complaint. I really felt that I had a valid reason for my reasons as to why I did not think I was at fault. I was not speeding, there was construction and there were several other vehicles in the road at the same time I was. I don't even remember seeing any flash so I did not have any reason to be concerned about violating any road laws. The corners were not very visible, and you had to make a guess as to whether I had crossed or not crossed. That alone made me feel like there was nothing concrete based on those facts and the others I presented to the judge.
