**ORDER**

September 29, 2023

The complainant alleged a city court judge failed to recuse on her criminal case and failed to correct mistakes on a criminal record.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Barbara Brown did not participate in the consideration of this matter.

## COMPLAINT AGAINST A JUDGE

This is defamation of harming my character to a more severe charge. My public record is for the public to view and my reputation is seriously attacked, sabotaged, damaged with falsification of facts.

I am asking the Arizona Commission of Judicial Conduct to CORRECT MISTAKES on my Criminal Record in Arizona police records with proof of completion. Next is getting my false charges Sealed which I am eligible in less than one year. I have lost faith in the Courts.

FIGHTING is a very serious word, one that I did not commit but the Court change my offense to. I have National Boards and State of Arizona License Certificates. The dedication of many years of schooling in obtaining these are all in jeopardy of anyone doing a simple background check till my record is Corrected, Sealed and Expunged.

Judge has an page write up of her work ethics submitted from the City Magistrate Merit Selection Commission.

My MISTAKE was my faith as a Christian in not having both Plaintiffs arrested when the police officers asked. My beliefs were neighbors do not arrest neighbors and recently had a Major life saving operation. was operating his bosses company in his residential parcel. Having workers enter with trucks to park at and departing after much noise, lights, disturbance in exiting in large work trucks with each truck with trailers, cement mixers for a total of exiting. moving vehicles at daily feet from my bedroom and bathroom. This was mornings a week at resulting in severe damage to my body, mind and spirit.

My decision to bring forth this complaint was finalized when the Plaintiff is again leaving in the pre-dawn of daylight in company work truck.
