ORDER

March 21, 2024

The Complainant alleged a justice of the peace violated the rules of ethics in multiple ways in an injunction against harassment case.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The judge was fairly new to the bench at the time of the hearing in the underlying case. After receiving notice of the complaint, the judge voluntarily sought additional training and met with a panel of Commission members to discuss the hearing and ways to improve her bench techniques. Thereafter, the Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

Commission member Regina L. Nassen did not participate in the consideration of this matter.

BACKGROUND

filed a false affidavit with the court in her protective order against me, so I contested it and requested a hearing to have the order dismissed. That hearing took place today.

COMPLAINTS

1. allowed the plaintiff to orally file an amended complaint containing all kinds of new and different sets of alleged incidents and facts than in the original affidavit.

2. encouraged the plaintiff to present an entirely different accounting, consulting with her triends numerous times, which I was not prepared for, and included numerous lies.

3. allowed the plaintiff to present completely new testimony of events happening beyond a year ago, also containing numerous lies.

4. When I was at the stand, the judge asked if I had any questions for the plaintiff. Although the plaintiff, in her new orally amended Petition she had just entered, did not mention at all the incident from Appendix B, that was one of the more pertinent areas I had a question about, since I never solicited a officer to obtain the plaintiff's information from I therefore asked the plaintiff why she thought I had solicited a officer for her information from I therefore asked the plaintiff why she thought I had solicited a officer for her own court as well, saying I had written in my request to contest the order that I had contacted a officer for the plaintiff's information from Why would I agree with the plaintiff in my own request to contest the plaintiff's order? VIOLATIONS

4.

1. The rule of the original petition (Form is violated, which states in Section 4: "If there is a contested hearing, a judge can consider only what you write here."

2. Rule 38(d) is violated, since nothing was provided in writing to me and I was given no choice of options on how to proceed as stated in 38(d)(2).

3. Basic rules of ethical conduct were violated.



I only became aware of the details of harassment and what her involvement was on and was thus granted an IAH against her on along with 2 others she supports, in and . I hadn't contacted the plaintiff for years but, in an ongoing effort, along with these 2 others, she has been spreading a false narrative and hatred against me, causing countless people to mistreat me, severe mental suffering requiring medical treatment and counseling, and, with this latest revelation on a reasonable fear of death.

I documented the beginning of this bigoted, homophobic harassment against me in my original petition, but it was removed since only the last year of incidents are considered, which I was not aware of at the time. Yet her granted petition and affidavit includes: " Why is that? That seems biased. It's additionally false as I never have threatened her nor committed any violence. I have certainly insulted her, but that's because she's a bigot, had mistreated me as such, and thus already posed a threat to my existence.

I don't know who friends are but I had asked some people I thought were trustworthy if they knew her address for the service of the order, not for my knowing. owns property anyway so her address is public information.

I have not been engaging in a course conduct against that even remotely resembles
" ", on social media or otherwise. The only stalking going on here is from her and the others and it has been reported as such to the police and FBI. I reached out to a friend who is a to see if he had any advice for me. Since and the 2 others have been spreading and supporting a narrative about me that includes being a " " with ", I had asked if he could verify the existence of any such reports. At that time he informed me, "

" That's the first and only mention of " " in my life as I've never heard of such before, and I never brought up my request to him again. I never once asked him to look up information on and I have a copy of our entire conversation, which he deleted after I asked him about IAH. I'm not sure how came to know/believe that or where " ' came from as I'd assume a Officer would know better than to share information about a victim with a suspect or related.

I would also request a remote video or telephonic hearing as I do have a granted IAH against her as well, and do not want to potentially be in her presence outside the safety of the court. Thank you.
