**ORDER**

December 26, 2023

The Complainant alleged a justice of the peace would not let her witnesses speak in an eviction proceeding.

The role of the Commission on Judicial Conduct is to impartially determine whether a judicial officer has engaged in conduct that violates the Arizona Code of Judicial Conduct or Article 6.1 of the Arizona Constitution. There must be clear and convincing evidence of such a violation in order for the Commission to take disciplinary action against a judicial officer.

The Commission does not have jurisdiction to overturn, amend, or remand a judicial officer's legal rulings. The Commission reviewed all relevant available information and concluded there was not clear and convincing evidence of ethical misconduct in this matter. The complaint is therefore dismissed pursuant to Commission Rules 16(a) and 23(a).

The judge dismissed the case and told me I did not have to move.

The attorney had asked me to come to an agreement prior to the court date and asked that a form be signed, after we left the court my sister and niece went to try to speak to someone regarding the agreement they discussed and The manager and attorney refused to speak to any of us or provide a document for us to sign.

They served me with a second set of eviction paperwork, no 10 day notice was ever provided to me and there was no proof of their allegation. I had enough proof to squash their allegation and I had never been late paying my rent in years.

The judge refused to listen to me or allow any witnesses to speak in my behalf he went as far as mutting my witness, I tried to tell the judge that they never gave me a form to sign but he would not let me speak he only allowed the Attorney for the apartment complex to speak. He looked at my evidence and pretty much dismissed everything I provided. He didnt address that they did not have me sign anything, he just sided with them and told me I had until the to leave the premises.

It is so sad that a apartment complex can file fictious evictions and make sure to schedule all their court dates on the calendar for Judge because they know no matter if their paperwork is incorrect, or that they HAVE NO EVIDENCE, they have no need to worry because he will side with them and evict innocent tenants. They can give false statement and provide no proof to back up their allegations and Judge sides with them.

What has happened to the oath that this judge took, what has happened to facts and moral. This judge has obviusbly lost all his moral ethics and is doing such an UNJUST to many people.

ALL evictions cases with this Judge should be reviewed.
